#### Value for money examinations

- At its meeting on 12 October 2006, the Audit Committee approved my estimate of income and expenses for the financial year 2007/2008 and considered my proposals for new value for money examinations [AC(2)-09-06(p2)]. I am grateful to Committee members for their views and I am now in a position to update the Committee on my plans for value for money and other work across the central government sector and the NHS, including my decisions on the new examinations that I have added to the plans (Annex 1).
- 2. As I explained to the Committee when presenting my draft proposals, these value for money examinations have been selected, and are being designed, specifically to address the five core themes that I have identified from my three-year strategy for the work of the Wales Audit Office, namely:
  - examining how partnerships and collaborative working can be improved to maximise benefits to the public;
  - improving the quality of financial and performance management generally and in the NHS specifically;
  - facilitating whole systems thinking and responses;
  - strengthening corporate governance and tackling fraud; and
  - identifying, evaluating and helping public services introduce good practice.
- 3. Annex 3 sets out the extent to which the individual examinations listed in Annexes 1 and 2 will address these themes. In doing so, I am confident that this work, alongside the totality of my financial and value for money audit work across the public sector in Wales, will make a significant contribution in delivering the overall mission statement of the Wales Audit Office to 'promote improvement, so that people in Wales benefit from accountable, well-managed public services that offer the best possible value for money'.
- 4. Members will see that, having taken account of their views and following further consultation with officials from the Welsh Assembly Government's (Assembly Government) Department for Education, Lifelong Learning and Skills, I have decided to bring forward an examination of the education of looked after children. As a consequence, I have deferred my proposed examination of the Teacher Workload Agreement.
- 5. As the Committee is aware, in drawing up a list of examinations that I plan to carry out, it is important to retain a strong degree of flexibility to respond to changing circumstances, priorities and risks. For example, members will see that Annex 1 includes reference to my examination of arrangements for the provision of home oxygen supplies, which I have undertaken in response to correspondence.

6. In the coming year, there is an additional need for flexibility to take account of changes in circumstances that may arise in the light of any significant policy or expenditure changes that follow the forthcoming National Assembly elections. Changes in the membership of the Committee following the elections may also give rise to new concerns and I would, of course, seek to respond appropriately to such issues.
