1. Pwrpas y papur hwn yw rhoi adroddiad cynnydd ar weithredu 'Cymru'n Ennill' – Strategaeth Datblygu Economaidd Cenedlaethol Llywodraeth Cynulliad Cymru.

Y Cefndir

2. Cyhoeddwyd 'Cymru'n Ennill' ym mis Ionawr 2002 gan nodi nifer o dargedau i'w cyflawni erbyn 2010 a chan gadarnhau y mesurid y rhain yn erbyn gwaelodlin 2001. Cynhwysir y perfformiad yng nghyswllt y targedau hyn yn yr Adroddiad Blynyddol ac fe'i dangosir yn Atodiad 1 y papur hwn.
3. Mae gwaith yn mynd rhagddo i ddatblygu mesurau perfformiad economaidd a lles ategol.
4. Daw rhaglen gyfredol Cronfeydd Strwythurol UE i ben yn 2006. Cyhoeddwyd cynigion drafft y Comisiwn ar gyfer y cyfnod 2007-2013 ac mae'r rhain wrthi'n cael eu hystyried. Nod Llywodraeth y Cynulliad yw sicrhau bod unrhyw gefnogaeth o'r fath yn y dyfodol yn cael ei defnyddio, cyn belled ag y bo modd, i gefnogi ei hamcanion strategol ei hun. Bwriadwn adolygu 'Cymru'n Ennill' yn 2005 i ddarparu fframwaith strategol ar gyfer defnyddio Cronfeydd Strwythurol yn y dyfodol.

HEFCW has established a third mission committee to advise the council on strategy development in this area.

Higher Education Economic Development (HEED) plan updates (received August 2003) confirm that all Welsh HEIs now have innovation strategies.

KEF support of up to £50k per HEI is being made available to underpin innovation strategies set out in this year's HEED plan updates. *

2003 HEED plan updates report a total revenue of £1.3m to Welsh HEIs from IP in 2001/02 and a total of 33 new business spinouts from Welsh HEIs in 2001/02 (increase of 28% from 2000/01).

Innovation and Technology programmes have assisted over 3,005 businesses, 861 individuals, safeguarded and created 3,614 jobs.

Programmes secured £10.6m funding for R&D and new product development, leveraging in approx £25m private sector investment. Over 4,800 technical enquiries have been handled. 2,200 new product processes & services are under development. Since its start the Potentia project has achieved its 1,000th business start. *

The ITCs also facilitate the SMART Cymru programme, and the Commitment to Innovation programme. There are currently 137 companies on the CTI programme and 6 companies joined the programme during the period April 04 – Sept 04.

Following consultation, HEFCW has established a Third Mission (3M) Fund. Institutions have submitted three year 3M strategies and implementation of HEIs' innovation policies will be monitored via the strategies.

All HEIs in Wales have again participated in the UK-wide HE-Business Interaction Survey (now expanded into a HE-Business & Community Interaction Survey (HEBCIS)). Publication is expected in December 2004 and will include data that compares Welsh (HE) innovation performance with that of other areas across the UK.

Ten Welsh HEIs have submitted expressions of interest to KEF for support for collaborative research activity involving industrial partners in Wales. Projects to be funded will be confirmed by mid-December 2004.

CETIC* - Objective 1 funding secured for Phase 2 Centres of Excellence (CETIC) Programme.

CETICs Objective One has assisted 547 businesses to date with over 260 jobs supported and c £954,000 private sector investment secured. Centres of Excellence have been through a re-accreditation process. *

Future Technology Programme activities concluded in December. Final report and future action plans are in preparation. 2,000 individuals participated in the Programme.

IP Wales has assisted 339 businesses, supporting c100 jobs. To date, 35 projects have been approved under P2M3 with a grant allocation of just under £70m. For P2M4, there are a further 35 projects with nearly £16m committed in grant funding. *

Major bioscience conference held. Discussion with Cardiff University and College of Medicine about the establishment of a major research institute to include Phase II of the Wales Gene Park at Roath Basin.

Wales Innovation Network (WIN) has over 950 members. WIN attended the 31st International Exhibition of Inventors in Geneva.

KEF* - consultants report on KEF review received. WDA in process of implementing recommendations. Relay – The Wales Innovation Relay Centre has disseminated 1,934 technology opportunities to over 3,000 clients, handled 568 technical enquiries from which 376 technology transfer leads were generated. R&D proposals have been submitted to the value of over £7m. Welsh participation at the Hanover Fair brokerage event resulted in 32 business to business meetings, Farnborough Air Show brokerage event resulted in 58 meetings and 16 meetings were held between Welsh companies and 6 Austrian companies as a result of an inward mission.

Work with higher education

Assembly Government represented on HEFCW's new Third Mission Committee.

Merger of Cardiff University and the University of Wales College of Medicine announced November 2003.

Task and Finish group established by Cabinet Office to consider the role of the HE sector in economic development has submitted its report to Ministers.

Formal response awaited from Central Government to a number of key UK-wide studies on HE third mission activities – eg the Lambert Review, Lord Sainsbury's Innovation review and proposed science and innovation ten-year investment framework.

HEFCW's 3M committee is about to publish its first annual report to the Council. This report reviews activities over the past year and illustrates the many ways in which the HE sector is contributing to economic and social well-being in Wales. The report also contains advice to the Council in relation to future strategic direction in this area, including to:

- Treat third mission activities as a priority, making them integral to our interactions with the sector and with our partner organisations;
- Promote and encourage increased levels of collaborative activity in the third mission arena;
- Play an active part in taking forward the recommendations made in the Nexus Report;
- Seek ways of facilitating the full and proper engagement of the Welsh HE sector with the emerging SSCs as a matter of some urgency;
- Support HEIs in developing their strategic oversight of third mission activities in a way that pulls together knowledge and technology transfer activity, the skills and employability agenda and wider social/ community outreach into a broader conception and articulation of how each

HEI does, and could, relate directly to its local environment, while also continuing to play on the wider UIK and international stage;

- Develop a framework of metrics that will enable the Council to demonstrate and measure the sector's contribution to economic and social well-being in Wales;
- Further refine the Third Mission Fund in the event of additional funding becoming available for the period 2004/05 to 2006/07.

The Assembly Government, WDA and ELWa are all represented on HEFCW's 3M Committee, which will also play a key role in overseeing HEFCW's contribution to the implementation of the Nexus Report by the Assembly's HE and Economic Development Task and Finish Group.

The Assembly Government is also represented on the sub-group of HEFCW's 3M Committee that is overseeing the analysis of HEIs' 3M strategies, outcomes of which are due in November 2004.

Knowledge Economy Nexus was published in the first quarter of 2004-05. A joint ministerial implementation group has been established to oversee delivery of the recommendations within the report. The group met and

Questionnaires returns have stated that 6.5 jobs have been created and 130 jobs have been safeguarded as a result of the Business Support Programme's activities to date.

The programme has undertaken or been directly involved in 13 seminars and events attended by 263 delegates.

The findings of the Strategic Review of the Broadband Wales Programme were presented to the Economic Development and Transport Committee on 22 September 2004.

Since April 2004 the SME Broadband Support Scheme has helped connect 362 businesses across Wales with a broadband connection. The scheme provides increased financial aid of up to £3000 and has been extended to include those organisations in the voluntary and charity sectors.

The ELLEN project has been renamed CoGS (Connectivity Grant Support) and is likely to secure Objective 1 funding before the end of 2004.

Regional Innovative Broadband Support, (RIBS) – Project officials at the Broadband Wales Unit are
