- **Higher Education Report:** the Minister to provide the Committee with a copy of the report for the Higher Education Funding Council for Wales: Review of 'Post- 92' Higher Education in South East Wales.

- 5.1 The Committee was invited to outline its broad priorities for 2006-07 and beyond. The Committee agreed the following priority areas within the education and lifelong learning portfolio:
 - Further education and post-16 provision;
 - Higher education: structural reconfiguration and student support;
 - School teachers' workload agreement;
 - Counselling and advocacy services for young people;
 - Compulsory school funding;
 - Capital funding for school buildings (to meet the 2010 target);
 - Funds to implement recommendations in the policy review reports on special educational needs and school transport; and
 - Continuing professional development for teachers.

5.2 Janet Ryder felt that there should be an opportunity for the ELL Committee to scrutinise education expenditure in the local government settlement. The Chair agreed to raise this matter at the next meeting of the Panel of Chairs.

Action

- The Chair to seek an appropriate mechanism for effective scrutiny of education expenditure within the local government settlement at the next meeting of the Panel of Chairs;
- The Chair to write to the Minister confirming the Committee's budget priorities.
