Title: CONSIDERATION OF THE DRAFT BUDGET FOR 2001/2004

Purpose

- 1. The purpose of this paper is to give the Committee the opportunity to comment of the draft budget for the 3 years 2001/2004 as tabled by the Minister for Finance and Communities and debated in Plenary on 26th October 2000. I also include, for you to note, a summary of the current position in relation to the Results for 2003 in *Betterwales.com* and the benchmarks for 2010.
- 2. Standing Order 19 provides that each Assembly Minister who is a member of a subject committee shall seek its views on the draft budget and convey them to the Assembly Minister for Finance and Communities.
- 3. Attached to this paper are the following documents, relating specifically to this Committee:

Recommendation

4. That the Committee comments on the Draft budget at Annex 1 and notes the current position in relation to the results sections of Betterwales.com at Annex 5.

Background

- 5. The budget round was launched in May this year with a paper from Edwina Hart 'Building a Better Wales Together'. The Committee set out its priorities for the budget planning round in a letter from the chair to the Finance Secretary dated 12th July 2000 (Annex 2). The table at Annex 3 sets out how the budget addresses each of the Committee's priorities.
- 6. Edwina Hart then set out the government's draft budget on 26th October and, having taken account of the comments from subject committees, will move the final budget around 7th December 2000.
- 7. This year, the budget planning round has been characterised by a closer link between spending and outcomes and results. Committees looked at priorities linked to objectives and the *Betterwales.com* vision and this part of the round seeks to preserve that link.
- 8. To assist this, the Explanatory Notes (Annex 4) provide a commentary on the **main** sections of the draft budget setting out in broad terms what additional activities would result.
- 9. Although it is not an express requirement under Standing Orders, committees are asked to note the current position in relation to the results sections of Betterwales.com (Annex 5). At the beginning of the round, Mrs Hart indicated the intention to revise the Assembly's corporate plan and this remains the government's intention.
- 10. The table in Annex 5 represent work-in-progress. Having taken the views of committees and looked further at the detailed formulation of the results, a draft revision of *Betterwales.com* will be issued for public consultation immediately after the final budget has been approved. The final version of the revised *Betterwales.com* will be debated in Plenary in March 2001.

Our two main budget priorities are the development of a waste strategy for Wales, and improved integrated transport. We also feel that the Countryside Council for Wales, National Parks and Environment Agency should receive adequate funding to deliver their statutory responsibilities, particularly in relation to implementing the provisions of the Countryside and Right of Way Bill.

Members also strongly feel that the Sustainable Development Scheme should be the overarching strategy of the National Assembly from which all others, including Better Wales, flow. Sustainable Development should underpin all our policies and all bids for resources to deliver Better Wales objectives should be assessed for their long term sustainability.

DRAFT BUDGET ALLOCATIONS

EXPLANATORY NOTES

Environment Planning and Transport

Transport - the main implications of the draft budget are as follows;

New Construction and improvement

: + £4.0/6.0/8.0 million

- Enables the already committed start in 2002 on the first stage of the A465 Heads of the Valleys dualling between Tredegar and Dowlais Top to be taken forward over a shorter 3 year contract period; and allows us to bring forward the start on the A470 Lledr Valley Stage 2 near Dolwyddelan in Conwy to earlier in 2002. It also allows us to continue preparation of medium-term projects such as the A479 Talgarth Relief Road.
- Funds up to £1 million on community enhancement and slower speeds initiatives in villages.
 - enables us to continue funding a small and medium scheme programme over the period.

DBFO: Shadow Tolls

: + £ 4.0/4.0/4.0 million

- meets the full contractual commitment of the A55 DBFO scheme on Anglesey. (last years base line of £12M reflected a part year payment)

Renewal of roads and bridges

: + £1.0/6.0/6.0 million

- to fund start of noise reduction programme on trunk roads;
- to renew the failed carriageway pavement on the A40 between Raglan and Monmouth, including a noise reducing surface.

National Cycle Network

: + £500,000 for 2001-02 from carry-forward

- to fund further crossing point schemes on the trunk road network at Trawsfynydd on the A470, Bodelwyddan on the A55 near St Asaph, and Penyclip on the A55 west of Conwy.

Programme Support etc

: + £0.1/0.1/0.1 million

- to fund the Sustrans office in Wales to encourage and promote cycling and walking;

Bus fuel duty rebate

- : + £0/4/4 million, plus £2.5 million in 2001-02 out of carry-forward
- to meet the contractual commitment to fund the demand- led Bus Fuel Duty Rebate Scheme, which supports bus services as part of an integrated transport policy.

Community Transport Grant

: + £0.25/0.25/0.25 million

- to complement the ongoing review to improve the effectiveness of funding for community transport, in improving accessibility and encouraging greater integration of community transport within the broader public transport network
- the funding will enable expansion of the scope of support to rural community transport projects into urban as well as rural areas

Transport Grant

- : + £8.0/20.0/30.0 million, plus £1.0 million in 2001-02 from carry-forward
- to respond to Local Transport Plans and support funding of integrated transport strategies across Wales. The funding will enable expansion of the scope
- to support rail infrastructure improvements to help deliver better services for Wales
- to fund further expansion of Safe Routes to Schools projects guaranteed allocation of £0.5m; previously have made awards of £0.8m and £1.3m, subject to quality of bids expect to award some £2m each year

Other Local Authority Grants

: + £3.0/5.0/6.0 million

- to continue and significantly increase in years 2 and
- 3, the one-off special grant funding for local road safety schemes, to reduce road traffic casualties
- a 40% reduction in the number of people killed or seriously injured in road accidents; a 50% reduction in the number of children killed or seriously injured; and a 10% reduction in the slight casualty rate, expressed as the number of people slightly injured per 100 million vehicle kms by 2010.

Bus Partnership Fund

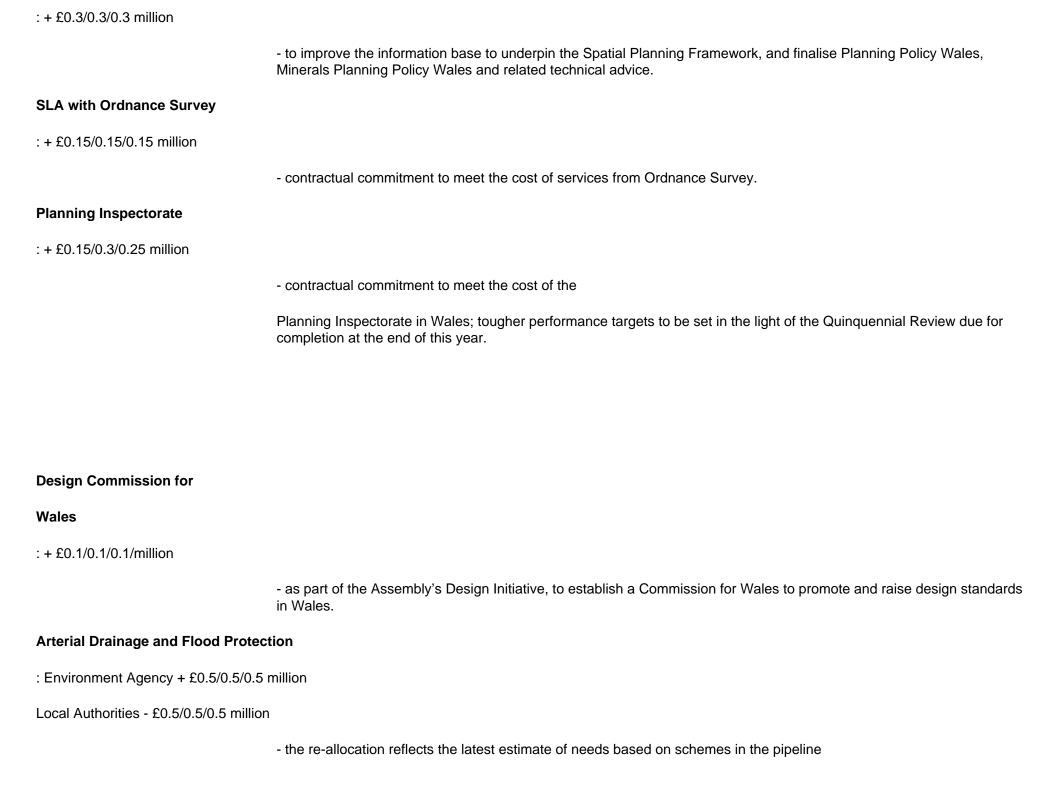
: + £1.0/2.0/3.0 million

- to increase provision of subsidised, socially necessary bus services
- the new funding provides a longer term commitment which takes account of rising tender prices and should enable local authorities to negotiate better value contracts with bus operators
- assist local authorities in developing the statutory bus strategies within local transport plans by 2003
- the Assembly is currently reviewing the operation of the scheme to increase its effectiveness and transparency

In addition to the draft budget figures the Finance Minister has agreed that transport will be considered a priority area for a share of any additional funds received by the Assembly.
