Diben

1. Nodi cynigion ar gyfer bwrw ymlaen ag adolygiad polisi'r pwylgor o gludiant cyhoeddus yng Nghymru.

Crynodeb/Argymhellion

2. Gwahoddir y pwylgor i ystyried y gweithgareddau, y themâu a'r amserlen amlinellol ar gyfer bwrw ymlaen â'r adolygiad, yn enwedig y materion hynny y ceir crynodeb ohonynt ym mharagraff 11.

Cefndir

3. Ar 18 Mai, cytunodd y Pwyllgor i gynnal adolygiad polisi o gludiant cyhoeddus yng Nghymru. Mae cylch gwaith yr adolygiad fel a ganlyn:

- *Ystyried polisiau cludiant cyhoeddus y Cynulliad (gan gynnwys gwasanaethau bysyst, rheilffyrdd a chludiant cymunedol) a nodi unrhyw newidiadau byr dymor o fewn y fframwaith statudol, rheoleiddiol a threfniadol cyfredol a fyddai'n hwyluso'r broses o ddarparu gwasanaethau sy'n well ac yn integredig a chael pobl i'w defnyddio.*
- *Ystyried a fyddai newidiadau hir dymor i'r fframwaith statudol, rheoleiddiol a threfniadol, sy'n gysylltiedig â chludiant cyhoeddus, yn hwyluso'r modd y caiff gwasanaethau gwell eu darparu.*

4. Gofynnodd y Pwyllgor am safbwytiau ystod eang o sefydliadau, a rhoddwyd copi o'r llythyr ymgynghori ar wefan y Cynulliad Cenedlaethol. Ceir crynodeb o'r ymatebion i'r broses ymgynghori yn Atodiad A.

5. Cytunwyd y dylai'r pwylgor benodi ymgynghorydd arbenigol i gynorthwyo gyda'r adolygiad. Ar ôl cystadleuaeth agored, penodwyd Denys Morgan gan banel dethol, o dan gadeiryddiaeth Richard Edwards.

6. Cafwyd peth oedi gyda'r adolygiad o ganlyniad i ymchwiliad annibynnol y pwylgor i safle tirlenwi Nantygwyddon.

Dulliau Ymchwilio

7. O gadw prinder amser y pwylgor mewn cof, efallai y bydd y pwylgor am ddefnyddio amrywiaeth o ddulliau ymchwilio, er enghraifft:

- *Sesiwn Saethu Syniadau* - sesiynau anffurfiol, preifat ar gyfer aelodau a swyddogion i weithio drwy'r materion sy'n codi;
- *Sesiynau Pwyllgor* - defnyddio cyfarfodydd pwylgor ffurfiol i wrando ar gyflwyniadau gan sefydliadau ac unigolion, trafod materion sy'n codi ac adroddiad ac argymhellion drafft y pwylgor. Mae dau le wedi'i neilltuo yn yr amserlen ar gyfer tymor yr hydref - 19 Tachwedd a 13 Rhagfyr.
- *Cynhadledd/seminar* - digwyddiad anffurfiol i rwydweithio â sefydliadau ac unigolion a thrafod arferion gorau, argymhellion sy'n codi o'r pwylgor neu adroddiad drafft y pwylgor;
- *Dod o hyd i wybodaeth* - casglu gwybodaeth ynghylch arferion gorau ym maes cludiant cyhoeddus mewn gwledydd eraill yn Ewrop, yn enwedig y gwledydd hynny lle mae'r pwerau perthnasol wedi'u rhannu rhwng lefel genedlaethol a lefel ranbarthol (gweler Atodiad C). At hynny, efallai y bydd Aelodau'r Pwyllgor am ymweld â gweithredwyr a defnyddwyr cludiant cyhoeddus yn eu hetholaethau neu'u rhanbarthau eu hunain, ac adrodd yn ôl i'r Pwyllgor wedi hynny;
- *Fforwm Trafnidiaeth* - manteisio ar arbenigedd Fforwm Trafnidiaeth Gweinidog yr Amgylchedd.

Themâu

8. Mae nifer o'r themâu wedi deillio o'r broses ymgynghori (gweler Atodiad B). I hwyluso adolygiad y pwylgor, bydd Gweinidog yr Amgylchedd yn cyflwyno adroddiad ynghylch datblygu Fframwaith Trafnidiaeth strategol i Gymru (gweler papur EPT-11-00 (p.3)), sy'n awgrymu rhai meysydd sydd angen eu harchwilio ymhellach.

Materion i'w hystyried

9. Cydnabyddir na ellir pennu cyfeiriad yr adolygiad yn llawn o flaen llaw, ac i raddau helaeth,

bydd yn dibynnu ar y meysydd o ddiddordeb a ddaw i'r wyneb yn ystod yr adolygiad. Fodd bynnag, da o beth fyddai cytuno ar amserlen ar gyfer yr adolygiad y gellir ei bwydo i mewn i'r rhaglen waith yn y gwanwyn, yr haf a'r hydref.

- **A yw'r pwylgor am nodi cwestiynau penodol y dylid mynd i'r afael â hwy yn ystod yr adolygiad?** Gallai cwestiynau lywio trafodaeth y pwylgor a rhoi arweiniad i'r sawl a fydd yn gwneud cyflwyniadau gerbron y pwylgor. Er mwyn rhoi digon o amser i baratoi, awgrymir rhoi'r cwestiynau i'r cyflwynwyr 20 niwrnod ymlaen llaw (byddai hynny'n golygu dosbarthu'r cwestiynau ar gyfer sesiwn 29 Tachwedd, yr wythnos hon).
- **Pa dystiolaeth sydd ar gael bod polisiau neu raglenni penodol yn effeithiol?** Gallai hyn gynnwys dwy elfen. Gyntaf oll, gallai gynnwys asesiad o bolisiau a raglenni a fabwysiedir gan y Cynulliad Cenedlaethol drwy archwilio dystiolaeth gymharol o'r "hyn sy'n gweithio" mewn mannau eraill yn y DU ac yn rhyngwladol. Yn ail, gallai gynnwys archwilio unrhyw dystiolaeth o'r "hyn sy'n gweithio" yng Nghymru a luniwyd ar ôl monitro a gwerthuso polisiau a raglenni sydd newydd eu rhoi ar waith neu sydd wrthi'n cael eu rhoi ar waith. Gallai'r Ymgynghorydd Arbenigol ddwyn ynghyd neu gydlynu'r dystiolaeth sydd ar gael gan adrodd yn ôl i'r pwylgor.
- **A yw'r aelodau am enwebu cofnodwyr i archwilio dulliau o arferion gorau ac adrodd yn ôl i'r pwylgor?** Oherwydd mynchy alwadau, byddai hyn yn rhoi mwy o hyblygrwydd na threfnu ymweliadau ar gyfer y pwylgor cyfan.
- **A yw'r pwylgor yn awyddus i wahodd cynrychiolwyr o'r Fforwm Trafnidiaeth i fod yn bresennol mewn cyfarfod o'r pwylgor, neu a ddylid anfon cynrychiolwyr i gyfarfod o'r Fforwm?** Unwaith eto, bydd angen i hyn gael ei gynllunio ymlaen llaw, a bydd angen i aelodau'r Fforwm Trafnidiaeth nodi'r dyddiadau fel rhai dros dro.

- **A yw'r Pwyllgor am ymgynghori ynghylch eu hadroddiad a'u hargymhellion drafft?** O gofio cymhlethdod a natur eang yr adolygiad, efallai y bydd y pwylgor am ymgynghori ynghylch eu hadroddiad a'u hargymhellion drafft. Gellid gwneud hyn drwy broses ymgynghori ysgrifenedig yn ogystal â chynhadledd, naill ai cyn y broses ymgynghori neu ar ôl hynny. Byddai angen i'r gynhadledd gael ei chynllunio ymhell ymlaen llaw, a dylai aelodau nodi'r dyddiadau. Yn ôl yr arferion gorau, dylid caniatáu 8-10 wythnos ar gyfer y broses ymgynghori.

- Supports WLGA submission

- Suggest a series of initiatives including travel corridors, smaller vehicles for rural areas, group hiring, one stop travel information, better community transport / volunteer cars, post buses, data warehouses, skills register, community engagement, paratransit (taxis, PHV's, community transport)
- Need to integrate transport with land use, economy, education, social services, recreation, health
