Pwrpas

1. Mae'r Pwyllgor Iechyd a Gwasanaethau Cymdeithasol wedi gwneud cais i ystyried Ystâd y GIG yng Nghymru. Mae'r papur hwn yn ymateb i'r cais hwnnw; gofynnir i'r Pwyllgor nodi cynnwys y papur fel sail i'w drafodaeth yn y cyfarfod ar 12 Mawrth 2003.

Crynodeb / Argymhellion

2. Caiff y papur hwn ei gyflwyno ar gais y Pwyllgor. Mae'n rhoi manylion am yr ystâd bresennol a'r camau sydd angen eu cymryd neu a fydd yn cael eu cymryd er mwyn gwella rheolaeth. Y nod cyffredinol yw galluogi'r Ystâd i fedru cefnogi'r GIG yng Nghymru wrth iddo ddatblygu gwasanaeth ar gyfer pobl Cymru sy'n fodern, hyblyg ac o fewn cyrraedd.

Y Cefndir

3. Ers cychwyn y GIG, fe rannwyd y cyfrifoldeb o gynllunio, darparu a rheoli'r adeiladau iechyd rhwng cyrff GIG canolog a lleol.

4. Gwelwyd nifer o newidiadau yn yr 1990au i Ystâd y GIG a'r staff cymorth technegol a'r staff proffesiynol oedd yn gyfrifol am ei ddatblygu a'i gynnal a chadw. Tan 1993 yr oedd swyddogaeth yr ystadau yn cael ei ddisbarthu'n bennaf drwy Awdurdod Gwasanaethau Cyffredin Iechyd Cymru (WHCSA) a'r 9 Swyddfa Waith Ranbarthol. Datgymalwyd y Swyddfeydd Gwaith Rhanbarthol rhwng 1993-1995 a chafodd WHCSA ei breifateiddio yn 1996. I ddechrau, trosglwyddwyd y cyfrifoldeb dros swyddogaeth yr ystad i'r 26 Ymddiriedolaeth GIG yng Nghymru ac yn dilyn ad-drefnu'r Ymddiriedolaethau yn 1998 lleihawyd y nifer i 15.

PROFFIL O'R YSTÂD

5. Ar hyn o bryd mae'r GIG yn defnyddio bron i 1150 hectar o dir ac yn berchen ar dros 130 o ysbytai, 250 o glinigau a chanolfannau iechyd, 50 uned iechyd meddwl, 100 gorsaf ambiwlans a 150 o eiddo amrywiol megis swyddfeydd, tai a storfeydd. Yn ogystal mae'n rhoi arian yn uniongyrchol ar gyfer darparu adeiladau iechyd eraill, yn enwedig ym maes gofal sylfaenol, megis meddygfeydd Meddygon Teulu.

6. Mae nifer o'r heriau sy'n wynebu ystâd y GIG yn ymwneud â'i oed. Mae tua 50% o ysbytai'r GIG dros 25 mlwydd oed ac mae traean ohonynt dros 50 mlwydd oed. Mewn perthynas â'r ystâd gofal sylfaenol ceir problemau penodol gydag addasrwydd swyddogaethol, gwneud defnydd o wagleoedd a chydymffurfiaeth statudol. Mae hyn yn adlewyrchu, yn rhannol, y ffaith bod dros 40% ohonynt yn eiddo preswyl sydd wedi ei addasu.

7. Mae manylion pellach am gyflwr yr ystâd ysbytai ar gael yn Atodiad A.

Ystyriaeth - Y FFORDD YMLAEN

Fframwaith Strategol yr Ystadau Cenedlaethol

8. Ers ffurfio Cynulliad Cenedlaethol Cymru yn 1999 mae ystâd y GIG a'r dull y caiff ei rheoli wedi bod yn destun dadansoddiad a dadleuon manwl. Yn sail i'r trafodaethau hyn bu'r tri adroddiad gan y Swyddfa Archwilio Genedlaethol i reolaeth a pherfformiad Ystadau'r GIG a gwnaeth yr adroddiadau hyn, ynghyd â gwaith arall a wnaed gan Adran GIG Cymru y Cynulliad a'r Gwasanaeth, arwain at lunio Fframwaith Strategol yr Ystadau Cenedlaethol ym mis Hydref 2002.

9. Mae'r Fframwaith yn gam pwysig wrth gyflawni gweledigaeth Llywodraeth Cynulliad Cymru at ddatblygu amgylcheddau modern, cyffyrddus, sydd o fewn cyrraedd ac y gellir eu haddasu, lle cynigir gofal i gleifion yn ddiogel ac yn effeithlon. Mae'n nodi'r 45 gweithred allweddol sy'n ofynnol gan gyrff y GIG sy'n berchen ar eiddo, Adran GIG Cymru ac Ystadau Iechyd Cymru. Mae'r manylion am y gweithrediadau hyn wedi eu darparu yn Atodiad B.

10. Maent yn cynnwys sefydlu Bwrdd Datblygu Ystadau, a Phanel Buddsoddi Cyfalaf.

Rheoli Perfformiad

11. Cyflwynwyd System Rheoli Perfformiad Ystadau ac Adnoddau (EFPMS) sylweddol ar gyfer y GIG yng Nghymru ym mis Ebrill 2002. Datblygwyd yr EFPMS drwy bartneriaeth rhwng Adran GIG Cymru â'r Gwasanaeth a chaiff ei reoli gan Ystadau Iechyd Cymru. Mae'r bas data yn monitro cynnydd yn erbyn dangosyddion Perfformiad yr Ystadau Cenedlaethol ac mae'n helpu Ymddiriedolaethau'r GIG i feincnodi eu perfformiad eu hunain.

Buddsoddiad Cyfalaf

12. Yr oedd Cynllun GIG (Cymru) yn nodi ymrwymiad y Cynulliad i gynyddu'r rhaglen gyfalaf a gaiff ei hariannu'n ganolog. Yn "Gwella Iechyd yng Nghymru" gwnaeth y Gweinidogion ymrwymo'r Cynulliad i ariannu rhaglen gyfalaf gyda £47 miliwn y flwyddyn o 2002/2003 ymlaen. Cyflawnwyd hyn ac yna gwellwyd arno gan nifer o gyhoeddiadau Gweinidogol yn ymwneud ag ariannu ar gyfer cynlluniau penodol. Mae'r ymrwymadau hyn wedi caniatáu nifer o gynlluniau sydd eu hangen i fynd yn eu blaenau ac mae'r rhaglen gyfalaf barhaus yn cynnwys 36 cynllun, y mae costau cyfalaf, o'u cyfuno, yn £452 miliwn. O'r swm hwnnw, bydd rhyw £81miliwn yn cael ei wario hyd at 31 Mawrth 2003 ac mae'r Ymddiriedolaethau yn rhagweld ar hyn o bryd byddant yn gwario ryw £89 miliwn yn 2003-04.

13. Mae ailsefydlu'r rhaglen gyfalaf a gaiff ei hariannu'n ganolog yn ddatblygiad calonogol, ond serch hynny nid yw'r lefelau buddsoddi cyfalaf yn ddigonol ar gyfer bodloni gofynion ystad iechyd modern ac effeithiol, ac amcangyfrifir y bydd galw am fuddsoddi cyfalaf yn y GIG yng Nghymru sy'n werth rhwng £1.65-£1.75 biliwn dros y degawd nesaf neu tua £170 miliwn y flwyddyn.

Rhaglen Adnewyddu Cyfarpar Cyfalaf drwy Gymru Gyfan.

14. Dros y ddwy flynedd diwethaf mae'r Cynulliad wedi rhoi arian i gefnogi rhaglenni adnewyddu cyfarpar achub bywyd yr Ymddiriedolaethau. I gychwyn targedwyd y gwaith o adnewyddu 2 sganiwr MRI a 6 sganiwr CT am gyfanswm o bron i £7 miliwn. Yn ogystal gwelwyd 2 sganiwr MRI a 2 sganiwr CT arall yn cael eu hadnewyddu yn

ogystal â chyfarpar meddygol a diagnostig arall o ddyraniad o £40 miliwn yn ystod 2001-02. Yn ystod y flwyddyn ariannol hon estynnwyd hyn i gyfarpar lluniau diagnostig gyda'r dyraniad o £8 miliwn yn cael ei ddefnyddio ar gyfer adnewyddu systemau mamograffeg ac uwchsain a chamerau gama.

15. Yn ogystal dyrannwyd £4 miliwn tuag at ddarparu 2 uned cathetr/cardioleg diagnostig ac angiograffeg. Ategir y dyraniad gan swm o £5 miliwn oddi wrth y Gronfa Cyfleoedd Newydd (NOF) ar gyfer darparu adnoddau/cyfarpar angiograffeg i'r Ymddiriedolaethau GIG yng Nghymru. Mae manylion pellach ar gael yn Atodiad C.

Gwerthu a chaffael

16. Er bod Ystâd y GIG wedi lleihau dros chwarter ers 1990 mae yna dal dros 60 o leoliadau a ddefnyddir heddiw na fyddant yn cael eu defnyddio at ddibenion iechyd ymhen 5 mlynedd. Mae digomisiynu'r lleoliadau hyn yn aml yn ddibynol ar ddatblygu adnoddau newydd er mwyn sicrhau bod cleifion yn cael eu trosglwyddo cyn eu gwerthu.

17. Cyflwynodd Adran GIG Cymru drefniadau newydd ym mis Ebrill 2002 ar gyfer cael gwared ar y lleoliadau hyn drwy gyflwyno tîm ymroddedig o weithwyr ystadau proffesiynol i Ystadau Iechyd Cymru. Awgrymir gan y dangosyddion cynnar bod y trefniadau newydd eisoes yn dechrau gwella perfformiad y GIG yn y maes. Yn Atodiad D gwelir bod y broses o werthu eiddo yn mynd rhagddi yn unol â'r rhaglen.

Gofal Sylfaenol

18. Gwnaeth Strategaeth Gofal Sylfaenol y Cynulliad – Dyfodol Gofal Sylfaenol – gydnabod pwysigrwydd adeiladau o safon uchel i gyflawni gwasanaethau o safon uchel. Bydd y Cynulliad yn cydweithio â'r Byrddau Iechyd Lleol (BILI) i ddatblygu gwelliannau i'r ystâd gofal sylfaenol a bydd y BILI yn arwain y ffordd wrth fynd i'r afael â'r materion hyn yn lleol. Gosodwyd targed cychwynol o Ebrill 2004 i'r Byrddau Iechyd Lleol ddatblygu strategaethau ar gyfer ystadau gofal sylfaenol ac mae Ystadau Iechyd Cymru, wrth weithio mewn partneriaeth â Bwrdd Iechyd Lleol Rhondda Cynon Taf, wedi datblygu strategaeth "pathfinder" ar gyfer ystadau gofal sylfaenol. Bydd y gwersi a ddysgwyd yn cael eu trosglwyddo i'r Gwasanaeth.

19. Mae'r Cynulliad hefyd yn rhoi cymorth i'r BILI a phractisau i hyrwyddo datblygiadau newydd drwy roi mwy o hyblygrwydd iddynt yn narpariaethau contractau Meddygon Teulu i ad-dalu practisau, a rhoi dros £4 miliwn i gefnogi'r hyblygrwydd hwn. Bydd y cynigion ar gyfer Canolfannau Adnoddau Gofal Sylfaenol yng Nghymoedd Gwent a Sir Fflint hefyd yn derbyn cymorth gan y Cynulliad."

Goblygiadau Ariannol

20. Amherthnasol o ganlyniad uniongyrchol i'r papur hwn. Bwriad y papur yw rhoi'r wybodaeth ddiweddaraf am y datblygiadau wrth reoli Ystâd y GIG yng Nghymru.

Capital Equipment

- Improving Health in Wales set out a vision for the delivery of healthcare in a modern, clean and well-maintained environment and stated that the replacement of outdated major diagnostic equipment was to be addressed as a first priority.
- During Q4 of 2000/01 (FY) the Welsh Assembly Government commissioned a major review of all diagnostic imaging devices and technology. The report was completed in Q2 2001/02. The report identified approx.£25m - £30m of equipment in NHS Trusts that was nearing, or had exceeded its nominal renewal date (estimated on the Royal College of Radiologists guideline of 7 years)
- In 2001/02 the Minister allocated £40.5m (in year EYF) which was to be utilised by Trusts to, primarily, undertake a major programme of equipment upgrades and replacements. Procurements were co-ordinated centrally and resulted in considerable financial and operational benefits to Trusts and Clinicians. Examples of the capital renewal programme included a combined CT/MRI scanner procurement, replacement of a number of major diagnostic X ray rooms, a substantial number of new ambulances and emergency response vehicles. The programme was completed within budget and agreed timescales.
- In 2002/03 the Minister has made a further £8m available to continue the capital renewal programme which is focussed on the upgrade to diagnostic mammography equipment, ultrasound and gamma camera scanning equipment. The evaluation and selection of suppliers has been completed, framework agreement established and equipment ordered and delivery is awaited.
- A further £4m central capital was made available during 02/03, which will be complemented by NOF funding for the procurement of two major diagnostic cardiology/catheter and Angiography suites.
- Proposals for a sustainable programme of centrally co-ordinated and funded major diagnostic equipment replacements in being considered as part of the review of the SAFF and capital investment planning processes
- Cancer & Coronary Heart Disease - The Welsh Assembly Government has also provided dedicated capital funding for cancer services equipment. In 2001-02, over £1.2m was provided for cancer services equipment. This funded histopathology equipment, diagnostic equipment for cancer, a CT Scanner and a Static MRI Centre. In addition £4.575m capital in total is being provided over 2002-03 and 2003-04; this funding is to be used for a new linear accelerator (linac) and a replacement linac both with associated bunker and works.
