- [6] **David Melding:** The role of this committee is to consider and report on the National Assembly for Wales (Legislative Competence) (No.6) Order 2008 (Relating to the Provision of Mental Health Services). The committee must conclude its work and lay a report before the Assembly by 13 June 2008, in line with the timetable set by the Business Committee.
- [7] The first issue for us to deal with is the terms of reference; I have them in front of me and I ask Members to approve them. The terms of reference are whether the legislative competence in the area identified in matter 9 should be conferred on the Assembly, as provided for in the Order, and also whether the proposed Order provides an appropriate framework within which to deliver the policy agenda on mental health and mental health services, or are the terms of the proposed Order too broadly or narrowly defined. Are we happy with those? I see that we are. Thank you.
- [8] Now, we must agree a programme of work and how to conduct our scrutiny. We need to issue a general call for evidence and invite written submissions from specific consultees over the Easter recess, with a deadline of 25 April for responses. We also need to take oral evidence in the summer term, and it is proposed that we start on 8 April with Jonathan Morgan. Is everyone content with these arrangements? I see that we are. Thank you.
- [9] That concludes our formal business. We will meet in earnest for our first committee meeting to deal with substantial work on 8 April. Thank you. That concludes our proceedings.
