Petition concerning the 'Consultation Draft Regional Waste Plan 1st Review. (Local Issues Action Group North Wales)

We the undersigned residents of Flintshire petition the Welsh Assembly Government to make arrangements so that the peoples of the County are properly informed and consulted regarding the N Wales Regional Waste Plan October 2004.

- 1. Extending the closing date of the N Wales Regional Waste Authority's consultation to 29th February 2008 or until such time that the people of the County have been properly consulted.
- 2. Ensuring that public meetings re the Plan are arranged in the North, South, East and West of the county of Flintshire
- 3. Ensuring that the 'rights' of the people of Flintshire County are preserved under the formal planning system, so that Planning Applications for waste facilities are not given approval by use of the Certificate of Lawfulness (CLOPUD) procedure as suggested in the draft N Wales Regional Waste Plan (October 2007) document.
- 4. Ensuring that Flintshire County Council makes provision for allocation of sites for waste management facilities in its Local Development Plan with due regard to the concept of reducing waste at source. The proposals for thermal treatment of waste and residual landfill as stated in the consultation document for the North Wales Regional Waste Plan must not be adopted as the desired strategy, without full and wide reaching consultations with all parties being carried out.
- 5. In view of the noise, smells, traffic impact and perceived health hazard associated with waste facilities, ensures that the North Wales Regional Waste Group precludes them from all business, industrial parks and sites within 1 kM of residential areas within the county of Flintshire.
