Deisebau Newydd

(i) P-03-140 Cyfnod Sylfaen

Geiriad y ddeiseb

'Yr ydym yn galw ar Gynulliad Cenedlaethol Cymru i ddarparu digon o gyllid ar gyfer cyflwyno'r Rhaglen Cyfnod Sylfaen yn llawn. Yr ydym yn credu bod y cyllid a gyhoeddwyd ar hyn o bryd gan Lywodraeth Cynulliad Cymru yn annigonol. Yr ydym yn gofyn i Gynulliad Cenedlaethol Cymru ymchwilio'n llawn i'r achos am ragor o gyllid.'

Cafodd y ddeiseb yma ei gyflwyni fel e-deiseb gan Mrs Claire Higgins.

Casglodd y ddeiseb 126 llofnodion.

Darparodd y deisebwr datganiad ategol, mewn Saesneg yn unig:

'The Foundation phase is a major pillar of the Welsh Assembly Government's aim to improve outcomes for our children.

The original roll-out date of 2006 was delayed to allow to ensure that enough staff could be trained up, and so that resources and funding could be organised. However a few months before the new curriculum is due to start I am horrified to find that there has not been enough money offered by WAG to allow the Foundation Curriculum to be implemented efficiently.

Within the Building the Foundation Phase documentation (2006) it was clearly stated that an "integral part of the roll-out will be a change in the adult to child ratios". We believe that staffing ratios should be a statutory requirement as these ratios were and are followed within all the pilot sites delivering the foundation curriculum. Directed play is a key component of the foundation phase. Surely - and as many parents will know - that to learn through a directed play then an adult needs to be actively involved. As the adult to child ratio climbs then the play becomes less directed and devolves into free play. We feel that the staffing ratios followed within all the pilot schools delivering the foundation curriculum should be enforced for every school by statute.

The pilot sites which had the lower staffing ratios have been very successful while following the new curriculum. However this funding shortfall could easily lead to a different delivery experience of the Foundation Phase Curriculum than has been observed within the pilots, but at the cost of our children's education.

Local authorities submitted clear costings in September 2007 during the LEAs Expenditure Sub Group, which were not then covered. The extra £5 million recently announced will not be sufficient to fully deliver and implement the foundation phase. Headteachers, teachers, governors, LEAs, parents have all called for £15 million which was the shortfall and out of new money not existing budgets.'

Wales will be starting an exciting journey into a completely different curriculum for our 3 and 4 years old in September 2008 - how terrible it will then be if only a few children get to experience the full benefits of the Foundation Phase.'

Cafodd y ddeiseb yma ei gyflwyni gan ddisgyblion o Ysgol Penmaes yn Aberhonddu.

Casglodd y ddeiseb 15 llofnodion.

Darparodd y Brifathro cynorthwyol datganiad ategol, mewn Saesneg yn unig:

The petition arose as a result of work our students have been undertaking alongside Mencap Cymru about greater participation by young people. During this work a discussion took place over the issues that most concerned our students in their everyday lives. The consensus of the group was that poor transport services in their area (which stretches from Ystradgynlais to Llandrindod - Brecon and Radnor) seriously impacted on their ability to be independent and access the services they require. As students attending a special school it is very difficult to take action to try to rectify the situation other than voicing their concerns to their Assembly Member and the Welsh Assembly Government, hence the petition.

The students agreed that they would like the Assembly Government to improve local transport linking Brecon and Radnor.

I am sure that some of our students would be willing to meet with members of the committee to express their concerns in person.'

(iii) P-03-141 Am Maes Awyr Llanbedr

Geiriad y ddeiseb

'Maes Awyr Llanbedr - Oes, Oes, Oes!

Rydym ni sydd wedi arwyddo isod o blaid datblygu maes Awyr Llanbedyr er mwyn dod â gwaith i'r ardal, hybu twristiaeth a datblygu'r economi leol.'

Casglodd y ddeiseb 1,240 llofnodion.

Darparodd y deisebwr datganiad ategol. Mae hwn wedi ei atodi fel PET(3) 12-08 Papur 3A.

(iv) P-03-149 Yn erbyn Maes Awyr Llanbedr

Geiriad y ddeiseb

'Yr ydym yn galw ar Gynulliad Cenedlaethol Cymru i gychwyn archwiliad cyhoeddus llawn o'r cynnig i greu canolfan hedfan masnachol ym Mharc Cenedlaethol Eryri, sy'n mynd yn groes i'r dibenion statudol y cafodd Parciau Cenedlaethol eu creu ar eu cyfer.

Cafodd y ddeiseb yma ei gyflwyni fel e-deiseb gan Cymdeithas Eryri - Snowdonia Society.

Casglodd y ddeiseb 156 llofnodion.

Darparodd y deisebwr datganiad ategol, mewn Saesneg yn unig:

'It is unacceptable that a proposal with such far-reaching implications, affecting an area which is very sensitive environmentally, should be allowed to proceed without proper public scrutiny. That could be provided under planning legislation. The Society has sought to establish by approaches to the Snowdonia National Park Authority as the local planning authority, that planning permission is required for the proposed development, but so far without success. The Assembly Government and the developer have proceeded on the basis that planning permission is not required.

The Society has also sought information that Welsh Ministers have fulfilled their legal obligations under section 62 of the Environment Act 1995 to 'have regard' to the statutory purposes of national parks in making decisions on land.
