The School Teachers (Consequential Amendments) (Wales) Regulations 2004

#### **EXPLANATORY NOTE**

#### (This note is not part of the Regulations)

These Regulations amend the Further Education Teachers' Qualifications (Wales) Regulations 2002 and the General Teaching Council for Wales (Fees) Regulations 2002. The amendments take account of the changes made by sections 132, 133 and 134 of the Education Act 2002 to teachers' qualifications, the work that may be carried in schools out by teachers and others and to the requirement to register with the General Teaching Council for Wales.

# The School Teachers (Consequential Amendments) (Wales) Regulations 2004

In exercise of the powers conferred upon it by section 214 of the Education Act 2002(**a**), the National Assembly for Wales makes the following regulations:

#### Name, commencement and application

**1.**—(1) These Regulations are called the School Teachers (Consequential Amendments) (Wales) Regulations 2004 and come into force on [ ].

(2) These Regulations apply only to Wales.

#### Amendment of Further Education Teachers' Qualifications (Wales) Regulations 2002

**2.**—(1) The Further Education Teachers' Qualifications (Wales) Regulations 2002(**b**) are amended as follows.

(2) In regulation 2 omit the definition of "1999 Regulations qualifications", and insert the following definition at the appropriate place —

" "school teachers' qualification" ("*cymhwyster* athro cymwysedig") means a qualification that confers upon a person the status of a qualified teacher within the meaning of regulation 5 of the Education (School Teachers' Qualifications) (Wales) Regulations 2004(c);".

(3) In regulation 3 substitute for sub-paragraph (a) in each of paragraphs (2), (3) and (4) the following sub-paragraph –  $\,$ 

"(a) a school teachers' qualification;".

# Amendment of the General Teaching Council for Wales (Fees) Regulations 2002

**3.**—(1) The General Teaching Council for Wales (Fees) Regulations 2002(**a**) are amended as follows.

(2) In regulation 3 substitute the words "to be registered by virtue of regulations made under section 134(1) of the Education Act 2002" for the words from "as a consequence" to the end.

(3) In regulation 4(4) substitute for paragraph (b) the following —

"(b) required to be so registered by virtue of regulations made under section 134(1) of the Education Act 2002,".
