## **QUINQUENNIAL REVIEW OF THE QUALIFICATIONS, CURRICULUM AND ASSESSMENT AUTHORITY FOR WALES (ACCAC)**

### **Report from the Reviewers, July 2003**

#### **Review of action to date**

The Minister for Education and Lifelong Learning announced on 27<sup>th</sup> April 2003 that she had commissioned Open Direction Ltd to undertake the Quinquennial Review of ACCAC following consultation with the then Finance Minister and the Assembly's Education and Lifelong Learning Committee.

The Review was to be overseen by a Steering Group convened by Financial Planning Division of the Welsh Assembly Government. That Group has met twice so far.

#### **Consultation**

As part of the evidence gathering process for the Review, we are undertaking a wide-ranging consultation with ACCAC's stakeholders and partners. In support of this a detailed Consultation Document was agreed by the Steering Group in early May, together with a representative list of prospective consultees. Members have a copy of that Consultation Document with their Committee papers.

Some 342 hard copies of the Consultation Document were distributed during May, together with a further 26 electronic copies subsequently.

In addition to this, ACCAC has placed a copy of the document on its own website, as has the Federation of Awarding Bodies. The National Assembly's website now contains a hot link across to the document.

ACCAC has sent a letter from Open Direction Ltd to the Headteacher or Principal of 2065 schools and colleges in Wales, as follows:

- 1,653 Primary Schools
- 228 Secondary Schools
- 51 Special Schools
- 30 Pupil Referral Units
- 28 FE & Technical Colleges
- 43 Independent Primary Schools
- 32 Independent Secondary Schools

and also to a further 283 Training Providers.

### **Engagement with ACCAC**

We have engaged actively with the Chairman and Members of the Authority, and the Chief Executive and staff of ACCAC.

We have attended a number of meetings of Authority Committees and working groups and have interviewed the Chairman and Chief Executive. We have also attended an ACCAC Staff Away Day which focussed on communication, equal opportunities and team working.

### **Other meetings scheduled**

We are scheduled to meet the Minister for Education and Lifelong Learning, the Sponsor Division and other Divisions within the Assembly's Training and Education Department. We have interviewed both the Authority's Internal and External Auditors and will interview certain other key stakeholders during July.

### **Responses to the Consultation**

At the time of writing we have received 28 formal responses to the Consultation Document and just 4 responses to the web-based questionnaire. These have been helpful, but at this stage of the Review it is not yet possible to draw any firm conclusions.

We have also contacted some fifty prospective respondents by telephone, reminding them of the importance of the Review and asking them to ensure that they respond to us by 11<sup>th</sup> July. The priority given to these respondents has been agreed with the Steering Group.

### **The Committee's View**

We would find it very helpful if Members were to offer thoughts in particular on the two key questions "Are the functions which ACCAC currently performs still necessary?" and "Should they be undertaken by an Assembly Sponsored Public Body?"

#### Adroddiad gan yr Adolygwyr, Gorffennaf 2003

#### **Adolygiad o weithgareddau hyd yma**

Cyhoeddodd Gweinidog Addysg a Dysgu Gydol Oes ar Ebrill 27<sup>ain</sup> ei bod wedi comisiyny Open Direction Cyf i gyflawni'r Adolygiad Pum Mlynedd o ACCAC yn dilyn ymgynghori â'r Gweinidog Cyllid ar y pryd a Phwyllgor Addysg a Dysgu Gydol Oes y Cynulliad.

Goruchwylir yr Arolygiad gan Grŵp Llywio a gynullir gan Is-Adran Cynllunio Ariannol Llywodraeth Cynulliad Cymru. Mae'r grŵp wedi cyfarfod ddwywaith hyd yma.

#### Ymgynghoriad

Fel rhan o'r broses casglu tystiolaeth ar gyfer yr Adolygiad, rydym yn cynnal ymgynghoriad pell-gyrhaeddol gyda budd-ddeiliaid a phartneriaid ACCAC. Er mwyn cefnogi'r broses hon, cytunwyd ar Ddogfen Ymgynghori fanwl gan y Grŵp Llywio yn gynnar ym mis Mai, ynghyd â rhestr o'r rhai y dylid ymgynghori â hwy. Mae gan Aelodau gopi o'r Ddogfen Ymgynghori gyda'u papurau Pwyllgor.

Dosbarthwyd rhyw 342 o gopïau caled o'r Ddogfen Ymgynghori yn ystod mis Mai, a 26 o gopïau electronig wedi hynny.

Yn ychwanegol at hyn, mae ACCAC wedi gosod copi o'r ddogfen ar ei wefan, fel y mae Ffederasiwn Cyrff Dyfarnu. Mae gan wefan y Cynulliad Cenedlaethol ddolen gyswilt draw i'r ddogfen hon.

Rydym wedi cyfweld ag Archwilyr Mewnol ac Allanol yr Awdurdod a byddwn yn sicr o fod wedi cyfweld â phrif fudd-ddeiliaid eraill yn ystod Mis Gorffennaf.

### **Ymatebion i'r Ymgynghoriad**

Ar adeg ysgrifennu'r adroddiad hwn, rydym wedi derbyn 28 o ymatebion ffurfiol i'r Ddogfen Ymgynghori a dim ond 4 o ymatebion i'r holiadur ar y wefan. Mae'r rhain yn ddefnyddiol, ond nid yw'n bosibl eto, ar yr adeg yma o'r Adolygiad, i dynnu unrhyw gasgliadau pendant.

Rydym hefyd wedi cysylltu drwy'r ffôn â rhyw hanner cant o ymatebwyr posibl, gan eu hatgoffa o bwysigrwydd yr Adolygiad a gofyn iddynt sicrhau y byddant yn ymateb erbyn Gorffennaf 11<sup>eg</sup>. Cytunwyd ar roi blaenoriaeth i'r rhain gyda'r Grŵp Llywio.
