National Assembly for Wales South Wales West Regional Committee Report for the Period May 2005 to March 2007

Introduction

1. The South Wales West Regional Committee first met on 20 May 2005, following the Assembly's decision to increase the number of regional committees to five, aligned to the five National Assembly electoral regions. The region covers the local authority areas of Swansea, Neath Port Talbot, Bridgend and small areas of Rhondda CynonTaff and the Vale of Glamorgan.
2. Regional committees are established under s63 of the Government of Wales Act 1998 and Standing Order 10. Standing Order 10 provides that their role is to advise the Assembly on matters affecting their regions and the work of public bodies there. Regional Committees are required to meet at least twice a year in the region.
3. The Committee has 11 members:

The Meetings

4. The Committee has met six times; details are set out below. Meetings have focused on a single topic, with several organisations making presentations followed by discussion and questions. Members of the public have been encouraged to take part in the questioning and discussion and at some meetings the public have been able to give their views and ask Members questions on any subject that is within the remit of the National Assembly.

5. Topics for the meeting were chosen by the Committee as issues where the local perspective could inform the Assembly Government's policy, or where one of the subject committees of the Assembly was undertaking a review of Assembly Government policy. Following each meeting the Chair has reported on the meeting either to the appropriate Minister or to the Chair of the subject committee.

The Chair reported on the meeting to Ann Jones AM, Chair of the Local Government and Public Services Committee, which was undertaking a scrutiny project on the subject.

17 March 2006

Topic: Education for 16 to 19-year olds, with particular reference to the Welsh Baccalaureate.
