## Gorchymyn Cynulliad Cenedlaethol Cymru (Cymhwysedd Deddfwriaethol) (Rhif 7) 2008 National Assembly for Wales (Legislative Competence) (No. 7) Order 2008

- Huw Lewis: We established the role of the committee at our informal meeting, which is to consider and report on the proposed National Assembly for Wales (Legislative Competence) (No. 7) Order 2008. The committee must conclude its work and lay a report before the Assembly by 13 June this year, in line with the timetable set by the Business Committee. So, there is a tight timescale. We have had informal discussions on the approach to scrutiny of the Order, and it was considered that the scope of the committee's work should be to decide whether the legislative competence should be transferred to the Assembly as provided for in the general principles of the Order, and whether the proposed Order provides an appropriate framework to deliver the policy proposals on domestic fire safety. In other words, are the terms of the proposed Order too broadly or too narrowly defined? I think that we have found our way through that discussion. Are you content with the scope of the scrutiny? I see that you are.
- [8] It was also suggested that, based around the scope of the committee scrutiny, we issue a general call for evidence and invite written submissions from specific consultees over the next five weeks, and that we take oral evidence in the summer term. Are you content with that approach, and do you agree with the arrangements for the call for evidence to be made? I see that you are all happy.
- [9] Unless there are other items that Members wish to raise—this is a record for the shortest meeting, I think—I can declare the meeting closed.
