This is the main networking event for the Pembrokeshire social enterprise network.

WCVA is assisting Sustainable Energy Wales and other NGOs with an interest in renewable energy to establish the capacity of the sector to contribute to a community renewables strategy and the planned microgeneration strategy. Existing activity by the community renewables sectoris being mapped, and proposals are being prepared for increased activity. These documents should be ready by the end of the year.

PEN (Pembrokeshire Enterprise Network) supports the work of the Pembrokeshire Social Enterprise Network. PEN is a mutually supporting network formed by PLANED of business advice and support agencies who work throughout the county whether Pembrokeshire based or otherwise.

The ultimate aim of the Pembrokeshire Social Enterprise Network, supported by PEN is to encourage a strong network of advice and mutual support for and by local social and community enterprises which can communicate pan Wales. Although still at an early stage, various processes are already being undertaken towards this. A draft

The role of the Network is to

facilitate the sustainable development of social enterprises in Pembrokeshire by building a network of social enterprises, in order to :

- Share learning and best practice;
- Link with specialist support services;

- Encourage collaborative working;
- Raise awareness and promote a culture of social enterprise;
- Provide opportunities to be inspired by examples of social enterprise.

Under its RCA programme PLANED employs a Community Social Enterprise Officer to help communities to identify any social enterprise opportunities in their local action plans. To ensure co-ordinated support to existing and potential social enterprises PLANED recommended to key PEN partners a more focused partnership of Social Enterprise Business Support Services involving PAVS and PBI in order to bid for EU Objective 1 funds

The individual parties have introduced a specialist integrated service in Pembrokeshire, holding support in business development to social and community enterprise. The support ranges from encouraging new enterprises to start, through to assistance for established social enterprises with long term commitments to become better businesses for the community. The project is funded primarily through EU Objective 1, Pathway To Prosperity and also by the partners involved. The project has been in place since last December, and has been working to full capacity from May 2006. To date it has received 41 enquiries, and currently is working with 21 different social enterprises within the county.

PLANED 's role

Developing innovative tools to identify community opportunities linked to the local economy;

Assisting communities to develop ideas for for social enterprises arising out of Area

Development Plans;

Participate in local and regional networks associated with Social Enterprise and member of DTA;CEW;WRDN;

Raise awareness and promotion of Social enterprise under leader+ and RCA programmes;

Facilitate and develop the Pembrokeshire Enterprise Network/Social Enterprise network as a means of fostering closer working relationships between the agencies that support Social Enterprise and to establish a mechanism for feeding into other regional and national networks e.g. SEN

PAVS role:

Contributing to the range of local and regional networks concerned with the development of Social Enterprise;

Building the capacity of the Association through training to deliver development support to voluntary organisations at all stages of their development in ways that will highlight the potential of the Social Enterprise model in sustaining the sector;

Contributing to the steering group to ensure that the project delivers a joined up approach based on the real needs of volulntary organisations;

Building awareness raising of Social Enterprise into all aspects of the Associations service delivery;

Providing information and signposting to the sources of Social Enterprise support available to voluntary organisations;

Developing a Social Enterprise as a model for the sector.

PBI role:

Develop new businesses within the Social Economy through working with potential clients up to and through the business planning process and beyond;

Encourage sustainable growth in employment and income amongst businesses that operate within the social economy provide specialist business advice for social economy organisations that increase employment or provide economic benefits by assisting social enterprises to grow and improve through the development of focused business plans and mentoring from personnel with knowledge to ensure social enterprise clients can run viable businesses which are sustainable in the long term.

Officers have been active in encouraging new and potential enterprises to make contact with other practitioners with relevant experience, and facilitated visits where appropriate, to allow the exchange of information and best practise. This will be developed through the practitioner based Pembrokeshire Social Enterprise Network.

Use existing networks and support emerging ones

The partners already have clients in these areas, with renewable energy being of particular interest. In these cases we also work with Pembrokeshire Coastal National Parks who offer a Sustainable Development Grant to social and community enterprises within the National Parks. All three partners sit on the SDF
