3. Safer Swansea Domestic Abuse Strategy 2006 – 2008

4. Key Issues for the Safer Swansea Partnership

- 4.1 *Tackling Domestic Abuse: The All Wales National Strategy, A Joint Agency Approach* provides an essential framework for community safety partnerships and requires additional resources to implement its expectations.
- 4.2 Swansea is trying to deal with Public Protection as an agenda and is striving to develop the joint agency approaches to risk identification, assessment and management. In the period 2005 2006 Swansea Domestic Abuse Unit received 3263 reports (of which 1879 were verbal) of domestic abuse. 3.9% of these incidents involved repeat victims. An 81% arrest rate was achieved for this period.
- 4.3 In a letter of response to the Draft Safer Swansea Domestic Abuse Strategy Consultation Mrs Edwina Hart, Assembly Minister for Social Justice and Regeneration, stated her belief that the Swansea Strategy "will be a valuable resource on a regional level". A response to the Consultation by the Assembly Working Group on Domestic Abuse and Violence Against Women also identified that the Strategy Action Plan's approach to tackling domestic abuse within BME communities required strengthening. An outcome - focused South Wales BME Domestic

Abuse Conference (open to representation from across Wales) is therefore being cross regionally planned and will be hosted by Swansea on 21st September 2007. Support for this exercise will be sought from the Assembly.
