Q13 Jeff Cuthbert: Will the First Minister make a statement on Health Challenge Wales? OAQ0262(FM)

The First Minister (Rhodri Morgan): Health Challenge Wales has got off to a very good start. Almost 5,000 action packs had been requested by 1 March, and calls from organisations wishing to play their part have exceeded expectations. The First Minister: The Minister for Economic Development and Transport made a written statement on 3 March 2005, clearly establishing that the leasing arrangement provided best value and that, in any case, there is no suitable rolling stock for purchase. We are responding to peak-hour congestion with a 20 per cent increase on capacity.
