**Sue Essex:** By 2007-08, the economic development and transport portfolio will have increased by 153 per cent since 1999-2000, compared with the Assembly average growth of 94 per cent. This will boost the economy of Wales and establish an effective transport infrastructure. Our investment in the Vale of Glamorgan rail link shows our commitment.
