- **Motion to approve The Assembly Learning Grant (Further Education) Scheme 2006 under Standing Order 29.3(iii)**

This Scheme aims to provide guaranteed financial support for eligible students in further education.

The Assembly Learning Grant (FE) Scheme:

- i. stipulates the conditions of use required to enable the Student Loans Company (SLC) to administer the Further Education

Assembly Learning Grant allocated by the Welsh Assembly Government;

- ii. sets out the criteria, which must be applied in assessing the eligibility of students in further education to receive an ALG and the varying levels of grant that can be awarded; and
- iii. sets out the methodology for calculating the payments, which apply under the ALG Scheme for the academic year 2006/07, including the levels of assessable income that must be used when carrying out any calculation.

- **Motion to approve The Assembly Learning Grant (Higher Education) Scheme 2006 under Standing Order 29.3(iii)**

This Scheme aims to provide guaranteed financial support for eligible students in higher education who are currently in receipt of an award under the existing Assembly Learning Grant Scheme.

This Scheme:

- stipulates the conditions of use by Local Authorities (LAs) of the Higher Education Assembly Learning Grant and its administration;
- sets out the criteria, which Local Authorities apply when assessing the eligibility of students in higher education to receive ALG and the varying levels of grant that can be awarded; and
- sets out the methodology for calculating the levels of awards to eligible students, including how assessable income is determined.

- **Education Maintenance Allowance Scheme 2006 under Standing Order 29.3(iii)**

This Scheme sets out arrangements for eligible young people to receive financial assistance to help them continue in education after compulsory school leaving age. Specifically it:

- stipulates the functions that the Student Loans Company will fulfil in its role as Scheme Provider and those functions to be undertaken by schools and colleges;
- sets out the criteria by which a young person's eligibility and entitlement to Education Maintenance Allowance (EMA) will be assessed and the structure and levels of payments; and
- outlines the contractual nature of the allowance both in respect of attendance and learning goals.

- **Motion to approve The Teacher Training Incentive Scheme under Standing Order 29.3(iii) (15 mins)**
This proposed Scheme makes provision for the National Assembly for Wales to pay grants by way of incentives for eligible persons to undergo a postgraduate initial teacher training course and by way of incentives for eligible persons to take up particular teaching posts for given minimum periods of time.

- **The Horses (Zootechnical Standards) (Wales) Regulations 2006**
The intended effect of these Regulations is to implement Commission Decision 96/78/EEC, which lays down the criteria for the entry of animals into equine studbooks (breed society listings of equines and their pedigrees). It applies to those societies who have been recognised as

operating an equine studbook under the EU Zootechnical legislation. The objective of such recognition is to enhance the trade in pedigree animals. It does this by harmonising equine studbooks so that animals can be registered in the appropriate studbook when exported to another Member State. These Regulations revoke and replace The Horses (Zootechnical Standards) Regulations 1992.

These Directions ensure that the public point of view is represented by a public champion on cleaning, hygiene and control of infection issues at the highest possible level in each NHS Trust and Powys Local Health Board (LHB). Each Trust will nominate an existing Non-Executive Director (NED) and Powys LHB an Associate Non Officer Member to fulfil this function. They will be required to act as an advocate to ensure that Community Health Councils and patients obtain information on issues relating to cleaning, hygiene and infection management.
