Ø **Rheoliadau Ceffylau (Safonau Sootechnegol) (Cymru) 2006**

Effaith y Rheoliadau hyn fydd gweithredu Penderfyniad y Comisiwn 96/78/EEC, sy'n pennu'r meini prawf ar gyfer cofnodi anifeiliaid mewn llyfrau gre (rhestrau'r gymdeithas fridio o geffylau a'u pedigri). Mae'n ymwneud â'r cymdeithasau hynny y cydnabuwyd eu bod yn gweithredu llyfr gre o dan ddeddfwriaeth Sootechnegol yr UE. Nod y cyfryw gydnabyddiaeth yw gwella'r fasnach mewn anifeiliaid pedigri. Bydd yn gwneud hyn drwy gysoni'r llyfrau gre fel y gellir cofrestru anifeiliaid yn y llyfr gre priodol pan gaiff ei allforio i Aelod Wladwriaeth arall. Mae'r Rheoliadau hyn yn dirymu ac yn disodli Rheoliadau Ceffylau (Safonau Sootechnegol) 1992.

These two sets of Regulations are required to give effect to Article 31 'Access to accommodation' of Council Directive 2004/83/EC and its regulations in respect of local authority allocations and homelessness assistance. This Directive lays down rules for the recognition of refugees and those in need of Subsidiary Protection and the content of the status given to such people. By virtue of Article 31 of the Directive beneficiaries of Subsidiary Protection must be given access to accommodation under equivalent conditions as other third country nationals legally resident in the UK. In this context 'accommodation' includes an allocation of housing and homelessness assistance.

Subsidiary Protection is equivalent to the existing category of leave called Humanitarian Protection (HP), which is granted by the Home Office to asylum seekers who do not qualify for refugee status but would be at serious risk to life or person if returned to their

state of origin. At present, HP is a form of exceptional leave to remain granted outside the Immigration Rules. In order to fully implement the Directive, however, HP needs to be formalised by bringing it within the Allocations and Homelessness Regulations.

- **Motion to approve The Environmental Noise (Wales) Regulations 2006 (15 munud)**

These Regulations will give the National Assembly for Wales the responsibility of preparing, reviewing and revising noise maps under the Environmental Noise Directive (END), except for maps applying to noise from non-designated major airports (all UK airports, apart from Heathrow, Gatwick and Stanstead) where the airport operators will fulfil this role. In addition, the Regulations will give the National Assembly for Wales responsibility for drawing up, reviewing and revising action plans (except for plans applying to places near major airports, where the airport operators will fulfil this role). All legal responsibilities for the mapping and action planning under the END for roads, rail and agglomerations (large continuous urban areas) will rest with the National Assembly for Wales. The Regulations also cover issues such as the identification of major roads, major railways and agglomerations and set out what approach and which methodologies should be used and the general procedures by which noise maps and actions should be prepared.

- **Motion to approve The Home Energy Efficiency Scheme (Categories of Works and Maximum Amounts of Grant) (No.3) (Wales) Determination 2006 under Standing Order 29 (15 munud)**

This Determination allows Eaga Partnership, the Home Energy Efficiency Scheme manager in Wales, to apply revised grant levels to applications for home energy efficiency measures. This will help ensure that eligible households are able to receive all of the energy efficiency measures that they are entitled to at little or no cost to them.

The Determination also allows the Scheme Manager to provide, as an option, oil central heating to those households considered to be 'hard to heat'. These are generally households who are not on the mains gas network and who may not have previously been able to receive assistance under the Scheme.

- **Motion to approve The Commissioner for Older People (Wales) Act 2006 (Commencement) Order 2006 (15 munud)**

This Order will commence provisions 1 to 22 of the Commissioner for Older People (Wales) Act 2006. The Act establishes and makes provision about the Office of the Commissioner for Older People in Wales and provides for a Commissioner who will help ensure that the interests of older people in Wales are safeguarded and promoted. The Act provides the Commissioner with specific powers to review the discharge of functions of public bodies in Wales and to review the advocacy, complaints and whistle-blowing arrangements made in connection with the provision of services by listed bodies and regulated service providers in Wales.

The Act confers powers on the National Assembly for Wales to make Regulations that give the Commissioner power to examine the cases of particular older people in Wales, and the power to give assistance, including financial assistance, to an older person in making a complaint or representation to, or about, certain bodies in Wales. The Act also confers powers on the Assembly to make Regulations setting out the arrangements for the appointment of the Commissioner, the term of office of the Commissioner and the reports of the Commissioner to the Assembly. The Act also enables the Assembly to direct the Commissioner as to the exercise of his supplementary powers and, with the consent of the Treasury, issue Directions as to the preparation of the Commissioner's yearly accounts.

- **Motion to approve The Paying Agency (National Assembly for Wales) (Amendment) Regulations 2006 (15 munud)**

The Paying Agency (National Assembly for Wales) Regulations 1999 (S.I. 1999/2223) gives the National Assembly for Wales the power to act as a Paying Agency in relation to the Common Agricultural Policy (CAP). These Regulations make a technical amendment to the 1999 Regulations, updating references within it to new European Regulations governing the CAP. The amendments are necessary to ensure that the 1999 Regulations are fully up to date, thereby avoiding any risk of legal challenge to the Assembly in the exercise of its functions as a Paying Agency from 16 October 2006.
