REPORT OF THE MINISTER FOR RURAL AFFAIRS

Foot and Mouth

- 1. As at 11:50 am on 16 July, the total number of confirmed cases in Wales stood at 101. 63 in Powys, 13 in Anglesey, 18 in Monmouthshire, 3 in Newport, 2 in Caerphilly, and one each in Neath Port Talbot and Rhondda Cynon Taff.
- 2. As at 13 July, 261,953 animals had been slaughtered under the disease control measures 35,294 cattle, 220,705 sheep, 5905 pigs and 49 goats, A further 32,941 animals are under surveillance, and 9000 sheep are under surveillance on Brecon Beacons.

[Figures are changing daily due to recent developments. Up to date figures available at the Committee].

- 3. At close of play on 11 July, 584,999 animals from Wales were registered with the Intervention Board under the Livestock Welfare Disposal Scheme 529,460 sheep, 7,371 pigs, 47,968 cattle, and 200 deer. Applications in respect of 404,309 animals have been processed to date. A further 116,254 animals are waiting to be processed. Animals withdrawn from the scheme so far total 32,522.
- 4. 43,218 movement licences for Welfare purposes have been issued in Wales to date. These include 11,801 occupational licences; 18,835 local licences; and 12,582 licences under the longer distance movement scheme. In addition, 1242 licences have been issued permitting the movement of animals onto common grazing land.
- 5. As far as compensation is concerned, claims from Welsh producers totalling nearly £48 million have been processed to date with only one livestock compensation claim outstanding.

Meeting with Rt Hon Margaret Beckett

6. I attended the meeting of Agriculture Ministers on the 4 July with the new Secretary of State for DEFRA, Margaret Beckett, in the chair. Our discussions ranged widely, with Foot and Mouth Disease top of the agenda. All were agreed that short term measures are essential for the Autumn sheep market

and rebuilding the livestock sector is an absolute priority. Both the short and medium term measures require concerted action across the UK. Detailed discussions are ongoing, including with the European Commission and Treasury.

7. At the request of the National Assembly's Business Partnership Council, I attended its last meeting on 6 July to discuss the economic impact of Foot and Mouth Disease. We had a useful discussion with contributions from the Wales Tourist Board, the Federation of Small Businesses and NFU Cymru. The suggestions from the group on how best to assist rural recovery are being considered by the Rural Partnership's task and finish group.

Rural Recovery Plan

- 8. Members will be aware that the Assembly set up a Task & Finish Group to assess the impact of Foot and Mouth on the rural economy and advise on measures to aid rural recovery. The Group was drawn from the Wales Rural Partnership with additional members from the agri-food sector, the Isle of Anglesey and Powys County Councils and Cytun.
- 9. The Group invited proposals from a wide range of organisations including Partnership members themselves and other interested bodies. The Joint Secretariat of the Partnership, comprising the WLGA, the WDA, WCVA and the Assembly, is drawing together a draft recovery plan from the proposals received for consideration by the Rural Partnership on 24 July.
- 10. A key issue will be to provide help to rural businesses in the areas which have suffered most. A range of measures is being considered to tackle the immediate problems arising from the disease and start to build the longer term regeneration of rural Wales. They include proposals to help tourism, agricultural and other rural businesses, provide a much need stimulus to help rural communities get back on their feet and provide support for individuals who have suffered stress as a result of the outbreak.

Rural Hardship Fund

11. The Assembly has authorised payment of over £1m by the Countryside Agency who are our partnerships managing the Rural Hardship Fund for Wales, to the ARC Addington Fund and the Royal Agricultural Benevolent Institution (RABI) to match funds they have disbursed in Wales from public donations for the relief of personal hardship. I very much welcome the important work which the Addington Fund, RABI and others are doing to help people in Wales at this difficult time.

LEADER+ Development Strategies

- 12. I am pleased to inform the Committee that I have now selected the Groups who will participate in the LEADER programme for 2000-2006. They are:
 - CRAI (Clwydian Range)

- Menter Mon (Anglesey)
- Glasu (Powys)
- SPARC/PLANED (Pembrokeshire)
- Northen Marches (Wrexham)
- Rural Conwy (Conwy)
- Adventa (Monmouthshire).
- 13. Fourteen applications were received, and I selected the seven Groups listed above based on the quality of their Development Strategies and the resources available. All of the applicants have been informed of this decision.
- 14. Together the seven applications approved represent:
 - A good geographic spread
 - A mixture of groups which have participated in LEADER I and II (Sparc, Menter Mon), new groups in areas previously covered by LEADER (Rural Clwyd, CRAI, Glasu) and new groups in new areas (Northern Marches, Adventa)
 - Good coverage of the three Themes/Measures three groups have opted for Adding Value, three groups have opted for Natural and Cultural Resources, and one group has opted for Quality of Life
- 15. The seven groups have been invited to prepare detailed Business Plans, and a decision about financial allocations will be made once these have been appraised.

We do not yet have detailed information on how local authorities have spent their allocations of the £12 million special grant - they have until the end of this month to use the money. But from the feedback we have been getting, it seems that they are using a mix of rate relief (for periods up to 12 months) and grants to cover other fixed costs using new 'economic well-being' powers in the Local Government Act 2000.

We wrote to all local authorities on 6 July asking them whether they would spend all of their allocations. This is with a view to redistributing any unspent special grant money to those areas worst affected. So far Powys, Pembrokeshire and Anglesey have all said that they would spend their full allocations.

The overall financial allocations are divided between three Actions. The three Actions consist of a mixture of funding from EAGGF, National Assembly for Wales, Other public sector sources and private sector funding. A breakdown of the £9.2 EAGGF is provided below:

Wales will therefore receive EAGGF of 14.7Million Euro (approx £9.2million) over a period of six years under LEADER+. The Assembly has allocated £1million pounds per year for the next three years in its Budget to match-fund LEADER+.

• Note to be provided on eligibility for subsidy where livestock had been culled – Gareth Jones (Foot & Mouth Operations)

This is a complex issue and action needs to be agreed across UK Agriculture Departments.

We will give the Minister a note to send to the ARD Committee this week.

• Additional Issue: Proposed 20 day standstill for animal movements

Given the volume of responses to the consultation exercise we are reviewing our proposals in the light of those responses. A standstill would have slowed down the rapid livestock movements that originally helped spread foot and mouth disease. However we have decided to make this issue part of a total approach to future disease control, which will also include biosecurity, animal identification and licensing. This will allow fuller veterinary and economic assessments to be carried out. In the meantime, current movement licensing controls will continue.
