INVESTIGATION INTO A BAN ON HUNTING WITH DOGS

Introduction

1. At its meeting on 7th February the committee agreed that its should conduct an investigation into the effect on Wales of implementing a ban on hunting with dogs. This paper sets out a suggested approach to the investigation.

Background

2. In December 2000 a plenary session of the Assembly referred the Hunting Bill to the committee to consider its bearing of on Wales. In February, the committee agreed to conduct an investigation into the effect on Wales of implementing a ban on hunting with dogs and to feed its views into the Westminster debate.

3. Although the Hunting Bill failed to become law before the General Election, the Queen's speech in June indicated that the Government would enable a free vote to take place on the future of hunting with dogs.

Next steps

4. With the committee's agreement it is proposed that a press release be issued after its meeting on 18th July inviting written submissions to the investigation. The release will invite evidence on *the possible consequences of implementing a ban, drawing attention to any factors of particular relevance to Wales.* A decision on whether further oral evidence gathering is required will be taken once written submissions have been received.

5. An agreed paper from the committee would be submitted appropriately once it becomes clear how the matter is to be handled in Westminster.

Action for the committee

6. The committee is invited to approve the approach outlined above and the attached draft release.

Agriculture and Rural Development Committee: Investigation into hunting with dogs

In December 2000 a plenary session of the National Assembly for Wales referred the Hunting Bill to the Agriculture and Rural Development Committee to consider its bearing of on Wales. Although the Bill failed to become law before the General Election, the Queen's speech in June indicated that the Government would enable a free vote to take place on the future of hunting with dogs.

The Agriculture and Rural Development Committee has therefore decided to conduct an investigation into the specific effect on Wales of implementing a ban on hunting with dogs and to feed its views into the Westminster debate. To this end, the committee invites written evidence on the possible consequences of implementing a ban, **drawing attention to any factors of particular relevance to Wales.**
