REPORT OF THE MINISTER FOR RURAL AFFAIRS

Agriculture Council

1. I will be attending the Agriculture Council in Brussels on 20 November which will, among other things, be discussing the reform of the sheepmeat regime. I will provide an oral update to the Committee on the outcome of the meeting.

New Entrants

- 2. At the Agriculture and Rural Development Committee on 20 June 2001 a paper was presented on proposals for assisting new entrants into farming ARD 11-01(p3). I agreed to report back to the Committee in the Autumn.
- 3. As part of Rural Recovery Plan for Wales, I announced on 8 August an allocation of funds directly to the Federation of Young Farmers' Clubs in Wales to support projects. £250,000 is to be allocated over three financial years £50,000 this year and £100,000 each year in 2002-02 and 2003-04.
- 4. The money will be used to support initiatives targeted at the younger members of the rural community. Initiatives will be aimed at helping to reduce rural isolation caused by Foot and Mouth Disease (FMD) and to alleviate stress and depression in young people in rural areas. Specific assistance will be directed at helping young people to make informed choices about their futures and developing agricultural skills including animal husbandry, stock handling and the driving of agricultural vehicles.
- 5. On 9 September at the Young Farmers' Clubs' Rural Forum, I stated that I would be looking at ways to give further assistance aimed at young farmers. I have now identified £50,000 for this financial year, which will assist in the activities of a newly appointed rural development officer and help establish a "Database for Opportunity", the aim of which is to give young people trying to get into agriculture the support to do so by matching them with people who can provide opportunities within the industry.
- 6. Farming Connect was launched on 17 September. It provides a comprehensive package of assistance aimed at improving, developing and diversifying farming businesses. Farming Connect includes

provision for farm business development plans to encourage farming families to analyse the strengths and prospects for their enterprises, training opportunities, access to specialist advice and a range of capital grants. These grants include the Farm Improvement Grant and Farm Enterprise Grant.

- 7. The Farm Improvement Grant will help farmers adopt best practice, to make animal welfare, hygiene and product quality improvements and to enhance, protect and maintain the environment of the farm. The Farm Enterprise Grant will address ways of widening the employment base on and off farm for members of farming families. Increases to the rates of grant had been previously announced on 16 August. Grants will be paid at a rate of 30% for Farm Improvement Grant and 35% for Farm Enterprise Grant. Importantly, an additional 10% on **both** Grants will be available to young farmers.
- 8. Provision is being introduced to provide extra application points for young farmers in order to assist them to enter the Tir Gofal scheme; these proposals will need the approval of the European Commission.
- 9. Farming for the Future: A new direction for farming in Wales, which I will be launching on 21 November, introduces a number of measures which will directly help young people. Briefly, ELWa is to review the provision of initial and vocational training to ensure that it supports the new direction of Welsh agriculture. Farming Connect will include specialist "Young Farmers' Angels" which will help young people access Farming Connect Services, help prepare business plans and access appropriate support. They will also promote share farming and help young farmers identify suitable partners and negotiate agreements. In addition, I propose to give Young Farmers top priority in allocating sheep and suckler cow quota from the National Reserve.

Farming Connect monitoring arrangements

10. At our meeting on 24 October, I agreed to update the Committee on the monitoring arrangements for the Farming Connect initiative. Arrangements are being put in place for the production of a regular overview chart, which will show latest performance against agreed delivery targets for each of the key elements of the programme. Mechanisms are also being put in place for assessing the regular feedback being sought from individual farmers, the farming unions, banks and other interested parties. The Farm Development Strategy Group is currently considering NAWAD/WDA outline proposals for evaluating the effectiveness of the programme, with independent reviews undertaken at 3, 5 and 7 year milestones; and an interim (first 12 months) review in summer 2002. I shall be circulating the overview chart to Committee members on a quarterly basis and will be keeping the Committee informed of the wider evaluation proposals.

Funding arrangements: Farming Connect & Rural Recovery Plan

11. At our meeting on 24 October, I undertook to provide clarification of funding arrangements for the Rural Recovery Plan and Farming Connect, distinguishing between Assembly and European money. The sources of funding for Farming Connect in 2001-02 are indicated in the table below. The Objective 1 bids, which have now been formally approved, embrace the whole of the Farming Connect service in

west Wales, while the Rural Development Plan monies include the provision of similar services for east Wales. It is intended that the additional resources made available as part of the Rural Recovery Plan will be disproportionately targeted at east Wales in order to help correct the imbalance in funding available from European sources.

Review of State Veterinary Service (SVS)

12. Following earlier undertakings that a review of SVS Services in Wales would be commissioned, terms of reference for the review have now been agreed and a reviewer appointed. Mr Lionel Walford, until 31 May 1999 Director of the Agriculture Department at the Welsh Office, has been appointed to undertake the review. The review will take into account the National Assembly's responsibilities for agriculture, health and rural development, more widely. It will be informed by experience in managing the FMD outbreak and also take into account recent changes within DEFRA to the management of the SVS. The review, which is expected to take about three months, will examine options for the development of veterinary and related services which reflect the National Assembly's responsibilities for policy and operational issues in these areas and provide advice on costs and implementation. The Committee will have an opportunity to consider the outcome of the review.

Relaxation of FMD controls on falconry and on hunting with dogs

- 13. Members will be aware that The National Assembly, along with the agriculture departments of Great Britain, announced on 15 November risk assessments on hunting and falconry. Falconry will be permitted under a DEFRA permit in Infected Areas from 19 November onwards. A consultation paper has been published with the conditions under which the current ban on hunting with dogs in England and Wales for FMD control reasons can be lifted from 17 December onwards.
- 14. In brief the proposals are as follows: Hunting of all kinds should continue to be prohibited in FMD Infected and Restricted Infected areas. The hunting of deer with dogs should continue to be prohibited in any part of the Controlled Area. (Currently England and Wales.) Coursing and use of terriers for pest control, which take place in more confined areas than other forms of hunting, should be permitted in FMD free and at risk counties. Other forms of hunting with dogs should be permitted in counties designated as FMD Free but that precautions should be taken to minimise the risk of disease transmission.

Export of Sheepmeat

15. I welcomed the announcement that the European Commission has approved the export of lamb and sheepmeat from counties in Wales, which have never had a case of foot and mouth disease. This means that lamb, beef and pork can now be exported from Conwy, Gwynedd, Carmarthen, Cardigan, Pembrokeshire, Denbigh, Flint and Wrexham. Beef and pork can been exported from Anglesey, Glamorgan, Bridgend, Swansea and Port Talbot, and pork only exported from Newport. This represents major progress, and the prospects are good for the scope for exporting meat to be broadened over coming months. The export of live animals will take longer. The future export of both meat and live animals will be dependent on there being no further cases of FMD. This rapid return to exporting meat would not have been achieved if vaccination had been adopted.

GM Release Directive 2001/18/EC

16. The initial consultation on the implementation of Directive 2001/18 on the deliberate release of GMOs into the environment closed on 16 November. The results are currently being analysed and the analysis will be presented to the Committee at their meeting on 5 December.

Woodland Strategy

17. On 8 November, the positive work of this Committee was recognised in the full discussion on our woodland strategy, culminating in its unanimous adoption as National Assembly policy to support our sustainable development commitment. I will be referring several points to the National Assembly Woodland Forum which is shortly to be set up. I will report back to the Committee on progress at the Woodland Forum.

Ystwyth Valley Woodland and Community Development Initiative

18. Progress is being made on implementing the Ystwyth Valley project which is part of the woodland strategy. A meeting in the Ystwyth Valley on 14 November has agreed a method of working between the key players in the local authority, public, private and voluntary sectors. The partner bodies will assist financially and professionally to enable and empower the inhabitants of the valley to maximise the socioeconomic outputs from the sustainable management of the woodland and other land in the valley. A project officer will be appointed to help the local community to develop the project.

Network Q Rally

19. The Network Q Rally of Great Britain takes place this week. This is a hugely important event which brings in between £16m and £20m to the Welsh economy and places Wales firmly in the glare of the world media, attracting as it does a global TV audience of some 135 million. This is the second year in succession that the rally has taken place wholly in Wales. I am reporting it here to this Committee, because it would not take place without the facilities provided in our National Assembly woodlands managed by the Forestry Commission. This is another example of the multiple-use of woodlands which we are committed to in our woodland strategy and shows the huge economic potential from looking at these woodlands as a multi-purpose resource, not just for producing timber or biodiversity.

Secondary legislation

20. I have attached to this report a list of forthcoming legislation, and other items of secondary legislation in the pipeline yet to be programmed, which I have undertaken to provide to the Committee on a regular basis.
