1. Apologies & announcements

1.1 Apologies for absence were received from Jocelyn Davies. The Chair welcomed Rhodri Glyn Thomas who would be representing her in accordance with Standing Order 13.3.

3. Matters Arising

BC(2)24-06 (Final minutes)

3.1 **Paragraph 11.1** The Business Minister referred to the requirement in the Government of Wales Act 2006 for a statutory instrument to set the date of the first meeting following the 2007 elections. She said she would be in a position to report back on progress in the Committee's next meeting.

BC(2)25-06 (draft minutes)

3.2 **Paragraph 4.4** Marion Stapleton confirmed that the Environment, Planning and Countryside Committee had not been notified about The Food (Emergency Control) (Revocation) (Wales) Regulations 2006 (BC(2)25-06(p6). She said that Government officials had felt that the Regulations did not deal with a cross-cutting issue.

3.3 **Paragraph 6.9** In response to a query from Rhodri Glyn Thomas about the recess dates for Easter 2007, it was confirmed that the default position referred only to the date of the start of the recess. It had previously been agreed that Members would not return between the end of the recess and the elections.

BC(2)26-06(p4)

4.1 The Chair referred to the Explanatory Memorandum accompanying this draft Order, which said "Any financial implications associated with the implementation of this Order will be expenditure incurred by local housing authorities. These costs will be met out of existing provision as resources for housing purposes are unhypothecated and are contained within General Capital Funding (GCF)." She said that the financial implications for local authorities could be substantial.

4.2 The Chair referred to the Cover Sheet accompanying this draft Order, which said there were financial implications for others arising from the Regulations. However, details of the financial implications had not been included in the Explanatory Memorandum. Marion Stapleton said that the Explanatory Memorandum would be amended to include the information. Kirsty Williams said that her group wanted to debate this draft Order.

4.3 The Chair noted that the Explanatory Memorandum said that "The First Minister wrote to all Subject Committees Chairs and the Chair of the Equal Opportunities Committee on 22 August 2006, notifying them of the draft Transfer of Functions Order. Unfortunately, this letter was not copied to Committee Clerks and it would appear not circulated to all Committee Members." Marion Stapleton said that letters would be copied to Committee clerks in future.

6.2 The Deputy Presiding Officer referred to the debate on The Closures Guidance (Railway Services in England and Wales) Order 2006 under Standing Order 26, which had been scheduled for Tuesday. He said that the associated guidance was not easily available to Assembly Members and asked if the debate could be delayed to allow time for Members to consider it. The Business Minister said she would consider this request and notify Members as soon as possible.

6.3 The Business Minister referred to the debate on The Sex Discrimination Act 1975 (Public Authorities) (Statutory Duties) Order 2006 which had been scheduled for Wednesday. She said that she had sought agreement from the UK Government for the functions under the Act to be transferred to the Assembly and that consequently, legislation specific to Wales would be brought forward in due course. She said that she intended to withdraw the motion and that she would circulate further information to Members.
