4.1 Lisa Francis referred to paragraph 19 of the Regulatory Appraisal, which said that "A small firms impact assessment is not planned. This is because small firms are likely to be less affected by these proposals than any other sector of the industry. The 28-day rule is not likely to present a problem to small businesses. Because they have few animals, keepers will notice lost tags quickly and replacing them will be relatively easy." She said that it was not clear whether a small business was determined by the number of employees or by the number of animals. The Business Minister said that this issue could be raised in the debate on the draft order.

Responses to Requests

BC(2)27-06(p12)

6.1 The Committee noted the Business Minister's responses to requests for items of business:

There was currently no intention to make a statement on the cost of out-of hours services. Members would be able to raise the issue during the Health Minister's questions.

There was currently no intention to make a statement on recent draft NICE recommendations on the prescription of osteoporosis drugs for women under the age of 75, as the recommendations were currently out for consultation, therefore it would be inappropriate for the Minister to comment until the consultation process had ended on 26 October.

A statement on delayed transfer of care.

There was currently no intention to make statements on the Home Secretary's announcement on measures to solve the overcrowding of prisons in England and Wales or on the implication for Wales of the introduction of ID cards, as both of these matters were non-devolved.

There was currently no intention to make a statement on GCSE coursework and SEN funding for gifted pupils as there was no change in policy and the Minister for Education, Lifelong Learning and Skills would be reporting back to the ELLS Committee in its next meeting.

There was currently no intention to make a statement on waiting times for patients with Epilepsy. Members could write to the Minister for Health and Social Services, if they had specific cases they wished to pursue.

6.2 Jocelyn Davies asked if the Business Minister would reconsider the request for a statement on waiting times for patients with Epilepsy. She said that there was a wider problem which would not be addressed by writing to the Minister for Health and Social Services on specific cases. The Business Minister said she would consider this request.

- 6.10 The Business Minister said that The Avian Influenza (Vaccination) (Wales) (No2) Regulations 2006 under Standing Order 24.27 (iv) and The Avian Influenza and Influenza of Avian Origin in Mammals (Wales) (No2) Order 2006 under Standing Order 24.24(iv), would be scheduled for 7 November.
- 6.11 The Business Minister said that the motion to approve the Local Government Settlement would be postponed from 15 November until January 2006. Jocelyn Davies said that it would be preferable to hold the debate before the end of the calendar year. The Business Minister said she would consider this request.
- 6.12 The Deputy Presiding Officer referred to the debate on the Annual Report of the House Committee, which was scheduled for 25 October, and asked if it could be postponed. The Business Minister said that it would be postponed until after the autumn half term and only 15 minutes would be allocated instead of 30 minutes.
