Title: Minister's Report

Purpose

1. To provide an update on a range of issues arising since the last meeting of the Committee.

Recommendation

2. Members to note the content of the report.

Background

3. The Committee last met on 1 July. This paper provides an update.

First Minister's International Activities

1 July. Meeting with the Korean Ambassador, London. Follow on from the visit to Wales of HE Mr Lee, Tae Sik, Ambassador of the Republic of Korea in May this year. Discussed the future prospects of the Korean economy and Korea's approach to economic development, relations with other far East countries, particularly in light of the expansion of the Chinese economy. Also discussed Korean/Welsh links and the possibility of future trade mission.

1 July. The 228th American Independence Day Reception, London. Attended celebration reception of US independence.

6 July. The Irish Consulate Reception. Attended reception to celebrate the enlargement of the European Union and the Irish Presidency.

20 & 21 July. Visit by the Latvian Commissioner. I met the then shadow Latvian Commissioner, Sandra Kalniete, over dinner at Miskin Manor on 20th July and at the Royal Welsh Show (RWS), Builth Wells on 21 July during her short visit to Wales. At the RWS, Ms Kalniete accompanied me for courtesy calls on the NFU, FUW, Young Farmers and CLA stands and later met the Minister for Countryside, Environment and Planning, Carwyn Jones, at the Welsh Assembly Government pavilion. Discussions centred on the exchange of information and sharing of best practice between Wales and Latvia. Ingrida Udre has subsequently been nominated as the Latvian Commissioner.

31 August - 1 September. Visit by a group of journalists based in the UK but working for Chinese publications, radio and TV. I met with a group of journalists to raise the profile and knowledge of Wales in China and to give the journalists an

opportunity to question me about my forthcoming trip to China. The two day programme also included interviews with the Welsh Development Agency, Wales Trade International, Wales International Consortium, tours of the Millennium Stadium, Cardiff Castle, Swansea Technium & Rhosilli Bay.

4 – 9 September. Visit to Shanghai, Xiamen and Beijing. I accompanied a trade mission of some 18 companies to China. I also met with senior Chinese politicians and led, on behalf of the UK Government, at the Chinese International Fair for Investment and Trade where, for the first time, Wales had its own stand and exhibition. The objectives of my visit also included encouraging Welsh companies to export to China, opening the WDA offices in Shanghai, opening the offices of Graig Shipping and Warwick International, launching the Wales International Consortium's ELI Foundation Programme and generally raising the profile of Wales in China.

30 September. Farewell Reception for the Japanese Ambassador. I attended the Farewell Reception for the Japanese Ambassador in London.

1 October. Lunch with Jim Carroll, Consul General of Ireland. I attended a lunch with Jim Carroll, Consul General of Ireland who has now left Wales to become the No.2 at the Irish Embassy in London.

12 & 13 October. Visit by Jean Yves Le Drian, President of the Brittany Regional **Council.** I met Jean Yves Le Drian, Regional President, and a delegation of 10 regional councillors, 10 cultural organisations, journalists and support staff. The Breton delegation was in Wales on a study visit, exploring the way different bodies (National Library, Welsh Books Council, S4C, etc) manage culture, Welsh language and creative industries.

Other Issues

Joint Ministerial Committee (Europe) (JMC(E)) – 14 September.

I attended this meeting that addressed the Working Time Directive and the new Commission and European Parliament.

On the Working Time Directive we discussed the impending College discussion of the Commission's draft proposals. Since this meeting, the Commission has adopted a draft legislative proposal to amend the existing Working Time Directive. Details can be found at the following link:

In its draft legislative proposal, the Commission has taken on-board member states' views on compensatory rest and on-call working (SiMAP/Jaeger judgements). It proposes to create a new category of "on-call" time where the "inactive" part of on-call is not counted as working time. As regards compensatory rest, the Commission proposes that this rest be taken within 72 hours rather than immediately as set out in ECJ case law.

On the individual opt-out, the Commission is proposing that a dual system be introduced. The individual opt-out will require prior collective agreement or agreement among social partners where appropriate. Where this is not possible (i.e. where the necessary structures for collective agreement did not exist), only then will the individual opt-out be available but with reinforced conditions to prevent abuses. The Commission has also proposed that the reference period for calculating the average working week be extended from the current 4 months to up to 1 year in certain circumstances.

The legislative proposal has now been transmitted to the Council of Ministers and the European Parliament for consideration.

We also discussed the composition of the new Commission and the opportunities to build up links with the new European Parliament.

"Wales in a New Europe : EU Regional Policy Post 2006" - 15 September

On 15 September I addressed the fourth meeting of the Wales European Forum, the focus of which was EU Regional Policy post 2006. The Forum, which was held at the University of Wales, Newport (Caerleon), was a joint event between the Welsh Assembly Government and the European Commission Representation in Wales. Other key speakers included John Neve (DTI), Ronnie Hall (DG Regional Policy), Tom Jones (WCVA), Chris Holley (WLGA), Santiago Loranca-Garcia (DG Employment & Social Affairs) and Jan Royall. Over 200 people attended, mainly from the public, private and voluntary sectors across Wales and contributed to interesting and thorough discussions about the future of regional policy.

A report of the proceedings is attached at Annex B of Paper 3 – New Structural Funds Regulations before the Committee today.

Environmental Technologies Workshop – 28/30 September

A group of leading young scientists, environmental experts and managers from eight of the new EU Member States (Czech Republic, Estonia, Hungary, Latvia, Lithuania, Poland, Slovakia and Slovenia) visited Wales to explore solutions for some of the environmental problems facing the UK and Central Europe. The visit was arranged by the Welsh Assembly Government in conjunction with the Foreign and Commonwealth Office and the British Council as part of the UK Government's Crossroads for Ideas initiative. The initiative provides new opportunities for exchanging ideas, experiences and skills, and for building new networks and partnership with the new Member States. During their stay they visited leading institutions and businesses, including Cardiff University's Geo-Environmental Research Centre, the Millennium Coastal Park, the University of Glamorgan and the Swansea Technium.
