Background

3. The Committee last met on 16 June. This paper provides an update.

First Minister's International Activities

16 June 2005 Visit of HE Mr Aramas Taurantas, Lithuanian Ambassador - I met Mr Taurantas who was in Cardiff for the BBC Cardiff Singer of the World Competition. He also took the opportunity to meet representatives from the WDA, WTI, the British Council and the Law School at the University of Glamorgan and attended the Committee meeting on 16 June.

1 July 2005 Participation in visit to the UK by the College of Commissioners - The Prime Minister hosted a day-long visit to the UK by the European Commission. As well as plenary sessions, I participated in 3 "break-out" meetings focusing on areas of specific interest to Wales. Participation in this day permitted the Welsh Assembly Government to contribute to the development of the shared UK / EU approach to the Presidency

4 July 2005 Informal meeting with Journalists from Belgium, Egypt, Latvia, Macedonia, Malaysia, Nigeria, Poland, Russia, Slovenia, Turkey and the UK - I held an informal meeting with these Journalists which was a British Council Wales-led project, to explore the role of the media in building trust between governments and nations. This was an opportunity to highlight Wales' expertise in open and accessible government and promote Wales internationally.

Other Issues EU Council Summit, 16 &17 June 2005

There were two main items of business – the Constitutional Treaty and the European budget for the period 2007 - 2013. Following the rejection of the Treaty in the French and Dutch referendums, the Council decided to pause for a "period of reflection," with no time limit decided for the exercise. The Council failed to reach an agreement on the budget issue, the key issues being the UK rebate and the Common Agriculture Policy. I made a statement to the Assembly on the outcome of the Council on 22 June.
