Title: In Year Transfer of Resources

#### **Purpose**

1. Standing Order 21 states that Committees should be informed of changes to in year budgets.

### **Background**

- 2. Committee were asked for their views on the 2006-07 budget proposals for Health and Social Services at the 3 November 2005 meeting. At this time discussions were still on going with the preparation of the Local Health Board and Health Commission Wales revenue allocation letter (issued 16 December 2005) and at the same time an exercise was being undertaken to reprioritise budgets within the MEG. As a result of these discussions further transfers are required and this is the earliest opportunity we have had to action these.
- 3. The Finance Minister traditionally holds two in year motions during the financial year, the first of which is in December. These motions allow for the transfer of funds between MEGs, the net transfer of funds from other Government Departments as well as the draw down of end year flexibility (EYF). However under SO 21 transfer of funds between BELs contained within a MEG only require the agreement of Ministers and the Health and Social Services Committee to be informed. In order to monitor financial performance and improve financial control it is important that the baseline budget is correct. The proposed transfers detailed in this submission correct budgets for which decisions have already been made but were too late to be included in the Final Budget in November 2005. Early in year corrections to budgets is essential so that the internal financial system reflects the correct budget for monitoring purposes.

#### Recommendations

4. The table at annex A details the changes that affect the Health and Social Services Main Expenditure Group (MEG). Committee members are asked to note these transfers.
