- [4] **Michael German:** Thank you, colleagues. For the record, I will state that this is the fourth permanent legislation committee to be established by the National Assembly for Wales. We have been given the illustrious title of Legislation Committee No. 4. The main role of the committee is to report and consider Government-proposed legislation. Other committees will consider legislation proposed by Members or committee.
- [5] The normal housekeeping arrangements apply for this committee. We operate through the media of Welsh and English. Headphones are provided, with simultaneous

translation on channel 1 and sound amplification on channel 0. In the event of a fire alarm, committee members should leave the room by the marked fire exit. No test is forecast for today, so if the alarm sounds it is real. Please ensure that all electronic devices are switched off. We have not received apologies for this meeting and all committee members are present.

- [6] For the record, I confirm that this committee will consider amendments to the Proposed Local Government (Wales) Measure. It is the first piece of work to be undertaken by the committee and it is Stage 2 of the process. We are obliged to consider and dispose of any amendments tabled to the proposed Measure by 27 March. The first meeting at which the committee will consider amendments will take place next Thursday, 5 March, at 1.30 p.m.. The deadline for tabling amendments for that meeting will be 5.30 p.m. today. Daily lists of amendments tabled will appear in the business notice, which is published on the internet.
- [7] I propose that we dispose of the amendments in the order in which they arise in the proposed Measure, and the marshalled list will be published on the internet on Monday. Are Members content with that? I see that you are. The next meeting of this committee will be held on Thursday, 5 March at 1.30 p.m. with a private pre-meeting at 1.15 p.m. Thank you for your attendance.
