Ensure that, for future reviews, sufficient time and resources are made available to maximise participation and thoroughness. Arrangements for the review should be set in motion within 4 weeks of each election.

The Assembly Government should work with the sector to promote more vigorously the use of secondments between the Assembly Government and the voluntary and community sectors, as set out in the Scheme.

Action taken. The Minister for Social Justice and Regeneration has agreed to meet the costs of recruiting a secondee from the voluntary sector to the Assembly, from within the 'Support for the Voluntary Sector' Budget.

Part of the secondee's role will be to promote more secondments between the Assembly and the sector. The success of the post will be reviewed after one year. There is scope to extend the secondment for up to five years, subject to the availability of funding.

Under the terms of the job description, the postholder will be required to:

- Advise on the Assembly's policy and procedures for secondments
- Develop a range of inward and outward secondment opportunities between the Assembly and the sector. These may include short-term secondment and shadowing opportunities (e.g. blocks of 5 days, or 6-10 days spread over a year), and 'continuous' secondments (e.g. one year)
- Develop and maintain close links with WCVA, CVCs and appropriate voluntary organisations, to identify the kind of secondments to and from the Assembly that would be of benefit to the sector.
- Negotiate and agree specific inward and outward secondments.

Action taken: Completed - revised VSPC Protocols have been drafted and discussed by the joint working group. At their meeting on 5 May, members of the group agreed that the new protocols should be put forward for approval to the Minister, and to the VSPC meeting on 13 June.

The revised protocols include:

- a requirement for agendas and papers for VSPC meetings to be submitted to the Secretariat not less than four weeks before meetings, and then to be issued by the Secretariat at least three weeks before meetings.
- A requirement for 3 meetings a year, with dates agreed 12 months ahead.
- A requirement for at least one meeting per calendar year to be held at a venue which is not in Cardiff (this reflects the suggestion made by the Minister for Social Justice and Regeneration in her letter to VSPC members dated 6 April 2005).
