### **BC(2)10-06 (p1) & BC(2)10-06 (p2)**

4.1 The Chair referred to the report of the Education and Lifelong Learning Committee, which had been circulated prior to the meeting, and which said that similar legislation had already been implemented in England. It was noted that the Minister had explained to the Committee that a decision had been taken by the Government to wait and see how the arrangements for Parenting Orders had worked in England before implementing them in Wales. Business Managers asked if this information could be included in the Explanatory Memorandums and commented that some parts of the Explanatory Memorandums were not clear. Marion Stapleton said that they would be made clearer and that the additional information would be included. Business Managers said they would like to debate these draft Orders.

### **BC(2)10-06(p7)**

4.2 The Chair noted that the Explanatory Memorandum accompanying this draft Order said that “*due to the delay in implementing similar legislation in England, the State Veterinary Service (SVS), who administer the Pre-Movement testing, in Wales and England are unable to put in place the necessary administrative process to allow the legislation to come into force in Wales at the same time as in England.*” Marion Stapleton said she would clarify the reasons for the delay and report back.

**6. Forthcoming Business**

**BC(2)10-06(p12)**

6.1 The Business Minister responded to requests from Business Managers and said that:-

- A statement on ambulance response times or a review carried out by the Welsh Ambulance Service, would be scheduled within the next weeks.
- There was currently no intention of scheduling a statement on the service changes at Llandudno, St. Asaph and Abergele hospitals as this was a matter for the local health/trust boards. The proposed changes had recently been published for consultation and it would be inappropriate for the Minister to comment or make a statement at this stage.
- There was no intention of scheduling a statement on the Communities First Programme following a recent report in the media.
- The Minister for social Justice and Regeneration would be making a statement on police restructuring when the position became clearer.
- There was no intention of scheduling a debate on the report of the Power Commission.

- There was no intention of scheduling a debate on transparency in Government. However, there had been an opportunity for Members to ask questions to the Business Minister on this issue in Plenary on 15<sup>th</sup> March.

### This Week's Business

Business Managers noted that there were two parts to Gwenda Thomas' original motion and said that the remaining provisions of Standing Order 31 should still apply. The Business Minister said she would consider the issue and report back to the Committee as soon as possible.
