3. Matters Arising

BC(2)11-06 (draft minutes)

- 3.1 Paragraph 4.2 Marion Stapleton reported back on issues relating to The Tuberculosis (Wales) Order 2006 (BC(2)10-06(p7)). Jocelyn Davies had asked if the delay meant that an untested animal could be transported across borders during this period. Marion Stapleton said that she had been informed by officials that Animals would be moved in the period until the implementation of this Order in Wales on 2 May 2006. Existing Government advice was for farmers to voluntarily arrange for animals from high risk areas to be Pre-Movement Tested. She said that a more detailed explanation had been circulated out of Committee.
- 3.2 Paragraph 4.5 The Chair asked if there had been any progress with arrangements for a debate on Gwenda Thomas' Standing Order 31 proposal. The Business Minister said that the consultation process for the proposed guidance was ongoing and that a motion would be timetabled when the process had ended. The Deputy Presiding Officer asked if an interim solution could be found which would satisfy the outstanding requirements of Standing Order 31.
