The Chair said that the Byelaw would be translated into Welsh once it had been agreed. The Deputy Presiding Officer said that it would be preferable if English and Welsh versions were available before the Byelaw was agreed.

- The Minister said that a statement on NHS Deficits would be scheduled once the HSS
  Minister had provided information to the Health and Social Services Committee, detailing
  Local Health Boards actual and accumulating debts, which was an action point from the 8
  March Health and Social Services Committee meeting.

7.1 Karin Phillips introduced a paper on the Parliamentary progress of Bills and said that the paper addressed the Committee's request for additional information about the Legislative and Regulatory Reform Bill. Peter Jones said that an issue which needed further consideration was whether or not there should be a mechanism for the Assembly, rather than only the Welsh Ministers, to be consulted on orders relating to the Assembly's functions. Lisa Francis said that this would need to be considered by the Standing Orders Committee. Business Managers noted that the Enterprise, Innovation and Networks Committee had considered the Legislative and Regulatory Reform Bill, but said that the Bill would impact on all subject committees' areas. The Chair said she would write to subject committee Chairs to suggest that they consider the Bill.

- 11.1 The Business Minister referred to the Railways Act 2005 and said she would be seeking Business Managers' views on the handling of the public consultation on the specification for the new cross country franchise. She said that Section 10(1) of the Railways Act 2005 required the Secretary of State to consult the Assembly before issuing an invitation to tender for all franchises that served Wales or before entering such a franchise agreement where no invitation to tender was issued.
