Ethol Cadeirydd Election of Chair

[1] **Ms Beasley:** Good morning, everyone, and welcome to the first meeting of Legislation Committee 2. The first item on the agenda is the election of the Chair, and so under Standing Order No. 10.18, I call for nominations.

[2] Jonathan Morgan: I nominate Val Lloyd.

[3] **Ms Beasley:** Thank you. Are there any other nominations? I see that there are none, and so I declare that Val Lloyd is duly elected Chair of the committee.

[4] **Val Lloyd:** I thank Members for their vote of confidence.

[5] **Val Lloyd:** I will start with the usual announcements. I have not received any apologies, but there is a substitution: Janet Ryder is substituting for Rhodri Glyn Thomas. I understand that she will be substituting for the duration of our Stage 2 considerations. We look forward to having your expertise.

[7] **Val Lloyd:** For the record, this is Legislation Committee 2 and we will consider amendments at Stage 2 to the Proposed Learning and Skills (Wales) Measure. This is our first piece of work, but this will be a permanent committee. Members have been advised that this is a formal meeting and that our main business will start next Wednesday and next Thursday afternoon.

[8] I remind everyone that the deadline for tabling amendments is 5.30 p.m. today. I know that that is quite short notice. Daily lists of amendments tabled will appear in the business notice. Government amendments have already been tabled for our notification.

[9] Our main business today is to discuss the order in which we will consider the sections as they appear in the proposed Measure. Are there any suggestions on that?

[10] **Jeff Cuthbert:** I suggest that we take them in the order in which they appear in the proposed Measure.

[11] **Val Lloyd:** Thank you. Are there any views on the amount of work that we might have and on the timescale that has been allotted to us?

[12] **Jonathan Morgan:** Looking at the timetable, I see that we are expected to conclude our Stage 2 consideration by 30 January, which means that we will sit during two working weeks. I understand that four potential slots are available to us in which to consider the proposed Measure. This is a substantial piece of work and, although I was not a member of the Stage 1 committee, I have gone through the paper work and the committee's report and have seen that many issues were raised by members of that committee and by people who gave evidence to that committee. Therefore, it is unrealistic for this committee to try to consider what will be potentially detailed and far-reaching amendments to this proposed Measure within such a tight timescale. My preference is that we seek the agreement of the Business Committee to an extension of the timetable. I do not think that we will need more than an additional two weeks, but I do think that this committee needs the flexibility to consider the amendments tabled in detail, and not just those tabled by the Government, but also those tabled by members of this committee as well; otherwise, we cannot do the job properly. [13] This is a substantial piece of legislation, and it will sit with the education sector for many years, and it is incumbent on this committee to do the job properly. Unless we have the additional time, we will not have the necessary ability to consider the detail of the amendments that have been tabled.

[14] **Val Lloyd:** Thank you, Jonathan. Are there any further comments on that? I see not. I see that Members are in agreement with Jonathan, so I will take that point forward after the meeting.

[15] We have agreed to ask the Business Committee for an extension, and we have agreed the order in which we will consider the amendments, namely to follow the order of the sections that they relate to. Does anybody wish to raise anything else? I see that there is no other business, so I thank you for your attendance and I close the meeting. We will meet again on Wednesday, 21 January.
