[5] **Janice Gregory:** Good morning to everyone. I will start with the usual issues that we need to go through at the start of any Assembly meeting. [6] **Janice Gregory:** Thank you for electing me to chair the committee that will scrutinise the Proposed Local Government (Wales) Measure. I think that it is an exciting Measure, which will form a way forward for local government, and I am looking forward to working with you all.

[7] We know, of course, that the purpose of today's meeting is to formally agree the committee's approach to the scrutiny of the Proposed Local Government (Wales) Measure. By way of background, I remind Members that the Measure was laid before the Assembly by Dr Brian Gibbons, Minister for Social Justice and Local Government, on 22 September 2008. The role of this committee is to consider and report on the general principles of the proposed Measure. We must conclude our work and report to the Assembly no later than 23 January 2009, in line with the deadline set by the Business Committee.

[8] Before this meeting, we had some informal discussions on our approach to the scrutiny of this proposed Measure. I suggest, as a framework for the committee's work, that we consider: first, the need for a proposed Measure to deliver its purposes of reforming the statutory basis of service improvement by local authorities and reforming community planning and strategies; secondly, whether the proposed Measure achieves its purposes; thirdly, the key provisions set out in the proposed Measure and whether they are appropriate to deliver its purposes; fourthly, the potential barriers to the implementation of the key provisions; and, fifthly, the views of stakeholders who will have to work with the new arrangements, if the Measure is passed. Are Members content with that approach? I see that you are. Thank you.

[9] Are you also content for us to issue a general call for evidence, to invite written submissions from organisations and individuals, and then to invite key stakeholders to give oral evidence over the coming weeks? I see that you are. Thank you all very much indeed.

[10] As I said, I am looking forward to working with you all on this proposed Measure and I am certainly looking forward to reading the written evidence that comes in. We want to invite as many people as possible to contribute evidence on this proposed Measure, and I am also looking forward to hearing the oral evidence. I should mention at this point in time that my husband is a local authority councillor for Bridgend County Borough Council and is also the chair of that authority's planning committee.

[11] Thank you very much for your attendance this morning. The next meeting will take place on 4 November, when the committee will conduct its first oral evidence-taking session with the Minister, Dr Brian Gibbons AM. Thank you very much. I now declare the meeting closed.
