In its communication on the WSIS of May 2003, the Commission undertook to report on the results of the Geneva Summit.  This Communication contains an appreciation of the principal results of the Summit, indicates the EU priorities and makes a proposal on how to organise EU inputs for the second phase of the WSIS.

This is the fourth annual implementation report on the Charter.
