**What are these documents?**

In February 2003, the Commission committed itself to a programme of simplification, codification,

consolidation, repeal and reorganisation of the large body of Community legislation (the 'Community acquis'). The aim was to ensure that to ensure it was up to date, burden free and easily accessible.

The documents provide an update on progress.

**Is it a proposal for legislation?**

No, but it reports progress in rationalising current European legislation.

**Does it require any action?**

No, but the Committee may wish to note the Commission's activity.

**COM (2003) 646 final: Report from the Commission on the Fourteenth Annual Report on the implementation of the structural funds (Our ref: 14415/03)**

**What is this document?**

This document provides an update on the implementation of all the structural funds (including all Community Initiatives) across the EU, outlining progress during 2002.

The report gives updates on progress in each of the funds and notes significant developments in the individual Member States and regions. Information on Wales can be found on pages 147-152.

**Is it a proposal for legislation?**

No, it's an annual implementation report.

**Does it require any action?**
