Item 4: European Union Presidency Briefing

Action

Members asked several questions in the context of the plans set out in 'Prospects for the EU in 2005 - The UK Presidency of the European Union'

- FCO officials agreed to provide the Clerk with a note on the UK position on the strategy for rural development and the protection of geographical indications e.g. Welsh lamb.
- The Committee would welcome timely updates from the FCO, via the Clerk, on the services directive and the chemicals regulation (REACH).
- FCO Officials agreed to provide the Clerk with a note on inter-governmental negotiations on climate change, with specific reference to aviation emissions.
- FCO Officials agreed to provide the Clerk with a note on state aid for regional airlines and airports, and the possible implications of climate change considerations.
- Given the Committee's interest in aviation issues, the Chair proposed that this should be a future agenda item, which was agreed and the Clerk was asked to include this in the forward work programme.
- FCO Officials agreed to provide the Clerk with a note on the clean coal agreements with China and India, including funding and the implications for such technology in the EU / UK.
