Thank you for inviting me to give evidence to the Communities, Equality and Local Government Scrutiny Committee on 13 March on Human Trafficking/Slavery.

I committed to provide Committee with further information on a number of issues. These are listed below with my responses:

- a note on the legal responsibility of a building/land owner where slavery/human trafficking activities may be taking place

Any person who knowingly allows their building or land to be used for the commission of slavery/human trafficking offences commits an offence. Depending on the person's involvement and complicity they may be charged with offences which include conspiracy and aiding and abetting the commission of such offences.

- to provide a copy of the play 'Sold'

Theatre Versus Oppression are currently completing the DVD of the play we funded them to produce and will be providing copies by 30 April. As soon as the DVD is received a copy will be forwarded to the Committee Clerk.
