**The Minister for Education and Skills (Leighton Andrews):** Local authorities have a duty to meet the needs of pupils requiring daily and residential bilingual special education. They are required to set out their proposals for Welsh-medium provision for learners with special needs within their Welsh education strategic plans submitted annually to the Welsh Government for approval.
