The Minister for Housing, Regeneration and Heritage (Huw Lewis): The Welsh Government policy includes continued support to the shared equity homebuy scheme and our intermediate rent scheme, Rent First, which allows a home ownership option. We are also

committed to the NewBuy Cymru scheme, due to be launched in the spring, which reduces the substantial deposit required on new homes.
