#### Adequate Counselling

**14. Aled Roberts:** Pa gamau y mae Llywodraeth Cymru yn eu cymryd i sicrhau bod digon o gwasanaethau cwnsela yn cael eu darparu i blant sy'n cael eu cam-drin mewn cartrefi gofal yng Ngogledd Cymru. OAQ(4)0922(FM)W

**Y Prif Weinidog (Carwyn Jones):** Yr awdurdodau perthnasol sy'n bennaf gyfrifol am wneud trefniadau i ddarparu gwasanaethau cwnsela, gan weithio ochr yn ochr ag asiantaethau allweddol fel yr heddlu a'r Gymdeithas Genedlaethol er Atal Creulondeb i Blant. #### Canol Trefi a'r Stryd Fawr yng Nghymru

**15. Eluned Parrott:** A wnaiff y Prif Weinidog amlinellu dull gweithredu Llywodraeth Cymru ar gyfer sicrhau y bydd canol trefi a'r stryd fawr yng Nghymru yn goroesi yn y dyfodol. OAQ(4)0933(FM)

**The First Minister:** Our continued commitment to support town centre regeneration will be a key part of our new regeneration framework, 'Vibrant and Viable Places'. The document has recently been subject to consultation and will be formally launched next month.

**14. Aled Roberts:** What measures is the Welsh Government taking to ensure that adequate counselling is available for victims of child abuse within care homes in North Wales. OAQ(4)0922(FM)W

**The First Minister (Carwyn Jones):** Lead responsibility for making arrangements for the provision of counselling services rests with the relevant local authorities, working alongside key agencies such as the police and the National Society for the Prevention of Cruelty to Children. I am satisfied that appropriate arrangements have been put in place.

**15. Eluned Parrott:** Will the First Minister outline the Welsh Government's approach to the future survival of Welsh high streets and town centres. OAQ(4)0933(FM)
