Alun Davies: Mae Llywodraeth Cymru wedi ymrwymo i reoli risgiau llifogydd yn unol â'r amcanion a amlinellir yn fy strategaeth genedlaethol ar gyfer rheoli risg llifogydd ac erydu arfordirol yng Nghymru. Yn 2013-14, byddaf yn buddsoddi £37 miliwn, gydag £20 miliwn yn ychwanegol trwy'r dyraniad cyfalafr canolog ac o gronfa ddatblygu rhanbarthol Ewrop.

Alun Davies: The Welsh Government is committed to managing the risks of flooding in line with objectives set out in my national strategy for flood and coastal erosion risk management in Wales. I am investing £37 million in 2013-14, supplemented by £20 million funding from central capital allocation and the European regional development fund.

15. Darren Millar: What action is the Minister taking to promote bathing water quality on Welsh beaches? OAQ(4)0019(NRF)

Alun Davies: Wales has the best bathing water quality in the UK. Last year, results showed that of Wales's 100 EU designated bathing waters, 97 met the mandatory standard, of which 75 met the higher guideline standard. We are working closely with Natural Resources Wales to ensure that beaches in Wales continue to achieve the highest possible standard.
