What are the main benefits to children and young people from having a residential outdoor education experience?

Residential provision of Outdoor Education is one of the highest impact models in education and is often the most memorable event during the time at school . By providing challenging activities away from home it is possible to develop Resilience , Independence , Communication skills , Growth Mindset and better interaction with others. It can show the positive benefits of physical activity to both physical and mental health . In a post-pandemic ( and new Welsh Curriculum ) world this is a double win as increased academic achievement and long-term health can be addressed through these visits . A residential visit within Wales can further foster a care and greater understanding of the country .

The equality gap widened . Post-pandemic we have seen peoples real-term incomes decrease and so these

valuable experiences can often not be afforded . And yet, it is for these less fortunate families that these experiences are so valuable and hard-hitting .

---

Having worked in residential outdoor education for 30 years ( although i write this as an Educational Visits Adviser ) i speak from experience here . We used to run almost entirely 5 day ( 4 night ) courses . These were incredibly high impact and without doubt better than shorter courses that have become the norm these days . But , these were predominantly Secondary age pupils and top juniors . There would be issues with capacity to provide for a 5 day course for all pupils . We now run mainly 3 day (2Night ) courses and , as our schools come from within Wales there is not a huge travel distance / time . One alternative approach would be to have 2 x 2 Night residentials at Primary level . Post Pandemic we have seen a massive increase in pupils with anxieties so possibly a 4 night course may be tough for some .
