## Your opinion

How important is outdoor education to children and young people's overall education and development?

What are the main benefits to children and young people from having a residential outdoor education experience?

It increases interaction with nature, building confidence and resilience through activities and challenges. It enhances communication and co-operation skills as well as introducing measured risk taking opportunities to encourage independent thinking and problem solving strategies. Classical indoor classrooms are becoming more ridgid and overcrowded, students can access their education in a more hollistic manner in outdoor educational classes where teachers and outdoor specalist can actually use their professional teaching experience and deliver life long learning opportunities that really do make a difference to our young learners. Not only educational benefits can be obtained from an outdoor based residential setting but students will obtain support for personal wellbeing through an immersive connection to nature. This in turn will solidify the importance of nature to students at a young age and this will be carried through their lives hopefully instilling the requirement to protect our environment for future generations.

Student lives are progressively becoming more immobile due to rise in financial pressures at home seeing an incease on the working hours of parents and guardians which has brought with it a rise in mental health and physical health issues of our younder generation. Lives are being led and lost looking through the lens of a phone, we need to allow our young learners the chance to live once more and experience life, nature, and the environment and devlop in a child centred hollistic way.

If funding for such expereinces was offered from a separate source of finances, not taking away from current over stretched schoool funding then the positive impact on young people would be immeasurable. From both mental and physical wellbeing stand points learners would be able to re-establish a solid foundation for furtehr learning to commence. Numerous studies have been conducted where the findings point to increased mental agility and prowess in classroom studies in direct relationship to increased time spent participating in outdoor learning activities. Students with ASD, ALN, and mental health issues would also be able learn new self-regulation strategies that they can employ back inside in the classroom.

If funding was not given to all learners there would be a high percentage of students who would once again be left out and the gap between Pupil Premium students and the majority of the student population would increase further still. If funding was taken from the school's already stretched budget the students would once again also suffer along with the teachers, as teachers would then fund trips from their own pockets to help learners so they wouldn't miss out. In addition money would also be taken from vital areas that fund the running and mantance of school life.

Is four nights/five days the best length for a residential outdoor experience?

Please explain your answer and highlight any possible implications from having a standard approach of four night/five day experiences (whether positive or negative).

The best length of time for a year 6 pupil would be between 2 to 3 nights away from home maximum. This is speaking from experience. I am both a teacher and an outdoor educator. Students who participate in residential experiences will have a lot of emotional and physical issues to contend with. Most learners that have stayed at the establishment where I work have never been away from their families before and arrive with deep seated anxiety. The immersive experience that is provided by an outdoor residential is not a 9am to 3pm school day. Learners are engaged in ongoing tasks from life skills, communication, education, phyiscal and mental challenges every minute of every day that they are on the course. Even if this is in a monitored play session the learner will still be undergoing many expereinces they have to process and deal with. This is very tiring on the learner and the teachers who have to monitor their students 24 hours a day. A peak in exhaustion is after 3 nights away where in some cases it can be detrimental to the positive experiences gained from the trip in the first few days for some learners. It is also questionable on the ability of teachers and observing staff after 4 nights away with learners having often spent over 36 hours straight with no sleep on making judgements during the daily tasks with the learners.
