I am writing to you in response to the recent request for views on the terms of reference for Strand 1 of the forthcoming 'Inquiry into Poverty' being undertaken by the Communities, Equality and Local Government Committee.

The Wales Co-operative Centre welcomes the Inquiry into this important subject matter and believes that the proposed terms of reference are appropriate. We would like to offer our support to the Committee by sharing our significant experience in this area if required. Through our front line work in communities across Wales we have gained insight into the causes of poverty and its impact on different groups of people as well as experience about how poverty can be tackled effectively.

As well as developing co-operatives and social enterprises, the Wales Co-operative Centre works to tackle poverty as well as social, digital and financial exclusion. One of our four corporate objectives is to strengthen communities and promote inclusion.

A number of our projects work directly with individuals and communities to help prevent poverty and to mitigate its impact. Several of them are referred to in the Welsh Government's Tackling Poverty Action Plan. These include:

- 'Tackling Poverty through Financial Inclusion', an innovative project
 which promotes the use of rent accounts held with credit unions to
 safeguard the tenancies of 'at risk' tenants. The project, which is funded
 by the Oak Foundation, has undertaken extensive work with benefit
 recipients in Caerphilly and across South Wales;
- Our Financial Inclusion Champions work with a range of stakeholders, including local authorities, social landlords and other key partners including the voluntary sector, credit unions and advice providers to promote financial inclusion;

- The role of digital inclusion in tackling poverty and the effects of digital exclusion on individuals and communities.
- Social Enterprise development addressing specific market failure and how social enterprises contribute to addressing poverty.
