'Land may not be used or caused or permitted to be used as a regulated site unless (in addition to the owner holding a site licence) the local authority in whose area the land is situated –

- () is satisfied that the owner of the land is a fit and proper person to be the owner and (as the case may be) the manager of a regulated site, or
- () is satisfied that, where the owner does not manage the site, that the'.

This reinstates the requirement that both owner and/or manager satisfy the fit and proper person test.
