Bil Gwasanaethau Bysiau (Cymru) | Bus Services (Wales) Bill

1. What are your views on the general principles of the Bill, and is there a need for legislation to deliver the stated policy intention?

I have had a Quick Look at the bill, and the notion of an integrated sustainable system, which is eminently sensible.

My concern is around those services which support very rural buses.

We have a bus on four days, on two days it goes to Carmarthen, one day to Llandovery and one to Ammanford via Llandeilo. The bus is clearly meant for residents to go shopping or visit a doctor/dentist but are not suitable for linking into longer journeys given the return journeys are lunchtime/early afternoon.

I do not know how many people use these buses on a regular basis, but I am concerned that it is the sort of service which will be lost under the proposals. Please bear in mind in rural areas there are no reliable taxi services to offer alternative travel, so eventually once we are unable to drive we will be forced to move home. The bus although not ideal or that convenient at least is an option. It's currently run by Morris travel, but I'm sure if you let big contracts such as to Stagecoach they will not want to run the small bus services.

I think your proposals should look at expanding cross country buses eg from Lampeter down to Llandeilo to link into other travel opportunities, and not just look at buses which run on the main A roads and major settlements. We would regularly use public transport if it was a regular service and integrated into the transport system.

Please will you provide reassurance that rural buses will not be disadvantaged under the current proposals.
